SUMMARY ORDER OF REVOCATION

NOW on this 23 day of December, 2014, comes before the Kansas Board of Pharmacy (the "Board"), through its Investigation Member, the matter of Amtis Amani, Pharmacy Technician ("Respondent").

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedures Act, K.S.A. 77-501, *et seq.*, the Board's Investigation Member enters this Summary Order of Revocation in the above-captioned matter. After reviewing the investigation materials and being otherwise duly advised in the premises, makes the following findings, conclusions and order:

FINDINGS OF FACT

For purposes of this order, the Board's Investigative Member makes the following findings of fact:

1. On July 23, 2013, the Board has issued Respondent Pharmacy Technician Registration Number 14-14730 authorizing her to perform the functions of a pharmacy technician in the State of Kansas ("Respondent's Registration").
2. On September 18, 2014, Respondent was given a prescription by her physician for Adderall XR 30 mg ("Prescription").

3. On September 20, 2014, the Respondent had the Prescription filled at CVS Pharmacy on Johnson Drive in Mission Kansas.

4. On September 24, 2014, Respondent attempted to have the Prescription filled a second time by presenting a copy she had made to the Price Chopper Pharmacy on Wornall Road in Kansas City Missouri ("Price Chopper"). The Price Chopper Pharmacist became suspicious, ran a KTRAC report, determined that the same prescription had been filled four days earlier and refused to fill it.

CONCLUSIONS OF LAW

5. That pursuant to K.S.A. 65-1663 the Board may limit, suspend, or revoke a registration or deny an application for issuance or renewal of any registration as a pharmacy technician on any ground which would authorize the board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.

6. That the Board may take action against the license of a pharmacist for unprofessional conduct or professional incompetency as set forth in K.S.A. 65-1627(a)(3).

7. That K.S.A. 65-1626 (ccc)(7) defines unprofessional conduct to include intentionally falsifying or altering records or prescriptions.

8. The Respondent's copying of a prescription with the intent to use the copy to get the prescription filed multiple times constitutes intentionally falsifying or altering a prescription and therefore a basis to revoke Respondent's Registration.

ORDER

Based upon the foregoing findings of fact and conclusions of law, Respondent's Registration is hereby REVOKED.

NOTICES

The Respondent is hereby notified as follows:

9. The Respondent may request a hearing pursuant to the Kansas State Administrative Procedures Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.

10. If a hearing is not requested as described above, the Order revoking the Respondent's Registration, as a pharmacy technician shall become a final order of the Board, effective upon the expiration of the time to request a hearing.


11. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

12. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is:
