FINAL ORDER

NOW on this 8th day of June, 2004, the above matter comes before the Kansas Board of Pharmacy [Board] for hearing on the Petition to Revoke, Suspend or Otherwise Limit the Licensure of Respondent, pursuant to written notice acknowledged by the parties. Petitioner appears in person by and through counsel Marty M. Snyder, Assistant Attorney General, and Respondent Steven Roy Bramlet appears by telephone conference call from Guam.

Upon reviewing all documents filed in this matter and hearing the statements of counsel and Respondent and being fully and duly advised in the premises, the Board unanimously finds as follows.

Findings of Fact

1. Respondent, Steven Roy Bramlet, is currently and at all times relevant to these proceedings has been a licensed Kansas pharmacist pursuant to KSA 65-1627, having been issued license number 1-09647.
2. Respondent's last known address is 241 Condo Lane, #603, Tamuning, Guam 96913.
3. The Board has the express jurisdiction of these proceedings to revoke or suspend the license of any pharmacist licensed under the Kansas Pharmacy

Act pursuant to KSA 65-1627. Further, the Board has the express authority to assess civil penalties to persons in violation of the Kansas Pharmacy Act pursuant to KSA 65-1658.

4. The Board has the express jurisdiction to enact rules and regulations promulgated to carry out the Kansas Pharmacy Act. See KSA 65-1630. The Board has the jurisdiction to enforce its rules and regulations. See KSA 65-1627.

5. On August 6, 2003, the Texas State Board of Pharmacy entered Agreed Board Order #G-03-003, revoking Respondent's Texas pharmacist license #23411. A certified copy of the Order was provided to the Board.


Conclusions of Law

1. The Kansas State Board of Pharmacy may revoke, suspend or place in a probationary status the license of any pharmacist upon a finding that the licensee has had a license to practice revoked, suspended or limited by the licensing authority of another state, a certified copy of the record of the action of the other jurisdiction being conclusive evidence thereof. K.S.A. 65-1627(a)(12).

2. Because Respondent's license in Texas was revoked by a Final Agreed Order of the Texas Board of Pharmacy, the Board finds that Respondent has committed the acts alleged and has thus violated the statutes and regulations referenced herein.

3. The Board hereby orders Respondent's Kansas Pharmacy license revoked based on the Texas Agreed Order, effective this 8th day of June, 2004.

IT IS SO ORDERED.

NOTICE OF RELIEF FROM THIS ORDER

This is a final agency action. It is effective upon service, which shall be presumed to be three (3) days after the date indicated in the Certificate of Service below unless a stay is granted pursuant to KSA 77-528. Within fifteen (15) days after service of this final agency action, any party may file a Petition for Reconsideration with the Kansas Board of Pharmacy. Such Petition must state the specific grounds upon which relief is requested. The filing of a Petition for Reconsideration is not a prerequisite for seeking Judicial Review.

Judicial Review may be had by filing a Petition for Judicial Review with the Clerk of the District Court of Shawnee County, Kansas, within thirty (30) days of the effective date of this Final Agency Action as provided in the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions, KSA 77-601 *et seq.* The agency officer who may receive service of a Petition for Reconsideration or a copy of a Petition for Judicial Review is:


