SUMMARY ORDER OF DENIAL

NOW on August 13, 2018, comes before the Kansas State Board of Pharmacy through its Executive Secretary (hereinafter referred to as the "Board") the matter of Precision Compounding Pharmacy (hereinafter referred to as "Respondent").

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board enters this Summary Order of Denial in the above-captioned matter. After reviewing the renewal materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions, and order:

FINDINGS OF FACT

1. The Board has issued Respondent Pharmacy Registration Number 22-16424 to operate a nonresident pharmacy in the State of Kansas.
2. On or around June 26, 2018, Respondent submitted a renewal application for Respondent's Kansas pharmacy registration.
3. Respondent's renewal application was reviewed for compliance and marked incomplete for the following reason(s): Respondent did not provide a Kansas-licensed pharmacist to designate as a pharmacist-in-charge for the pharmacy.
4. The Board sent one or more emails or letters to Respondent's address of record requesting documentation to complete the renewal application by a specified date.

5. To date, the Board has not received the requested documentation from Respondent to complete the renewal application.

CONCLUSIONS OF LAW

6. Pursuant to K.S.A. 65-1627(e)(1), the Board may deny the renewal of any pharmacy registration upon a finding that the pharmacy has been operated in such manner that violations of the provisions of the pharmacy act of the state of Kansas or of the rules and regulations of the board have occurred in connection therewith.

7. Pursuant to K.A.R. 68-7-12a(1)(3), each pharmacy shall designate a pharmacist-in-charge, as defined by K.S.A. 65-1626, and amendments thereto.

8. Pursuant to K.S.A. 65-1626(uu), a pharmacist-in-charge means the pharmacist who is responsible to the Board for compliance and supervision.

9. Pursuant to K.S.A. 65-1626(tt), pharmacist means a Kansas-licensed pharmacist.

10. Respondent was required to designate a Kansas-licensed pharmacist as pharmacist-in-charge.

11. Respondent failed to designate a Kansas-licensed pharmacist as pharmacist-in-charge.

12. Respondent's failure to supply the Board with the requested documentation for renewal of the Kansas pharmacy registration is a violation of K.A.R. 68-7-12a.

13. Respondent's failure to comply with regulations promulgated under the Kansas Pharmacy Practice Act authorizes the Board to deny Respondent's pharmacy registration renewal application under K.S.A. 65-1627(e)(1).

ORDER

Based upon the foregoing findings of fact and conclusions of law, Respondent's Pharmacy Registration Renewal Application is hereby DENIED.

NOTICES

Respondent is hereby notified as follows:

1. Respondent may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231, within 15 days after service of this Order. If the outcome of the hearing is adverse to Respondent, costs of the proceedings shall be charged to Respondent.

2. If a hearing is not requested as described above, the Summary Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.


3. Within 15 days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to K.S.A. 77-613. The agency officer designated to receive service of a petition for judicial review is:


