WHY SHOULD I USE THE TOOLKIT?

SET PATIENT GOALS

What are the goals for your practice? Does it involve the health and safety of your patients? If so, the Provider Toolkit emphasizes patient safety by promoting safe medication storage and disposal and providing additional information about prescription opioids and stimulants for at-risk populations.

At K-TRACS, our goal is to promote patient safety, community health and prevention. Everything in the Provider Toolkit helps advance this goal, and we look forward to partnering with you to bring these important messages to more prescription drug consumers across the state of Kansas.

EXTEND THE CONVERSATION

We encourage you to continue to have important conversations with your patients in person, and the Provider Toolkit contains materials that can supplement those conversations with take-home materials and digital promotions. Together, we can prevent prescription drug misuse, abuse and diversion.

WHAT MATERIALS SHOULD I USE?

CONSIDER AUDIENCE

Who is your target audience? What group of patients, consumers or customers are you trying to reach with your message?

The toolkit provides messaging for general audiences, but also distinguishes targeted messaging for older adults (Baby Boomers, 55+) and teenagers and their parents. These specific materials are labeled as such.

Determine who your target audience is and whether you can offer additional customization based on your community characteristics. Then select the toolkit materials that will achieve your goals.

CONSIDER PLACEMENT

Where does your target audience spend the most time? Social media? Online shopping? Reading newspapers? Listening to radio? You'll want to consider your audience demographics (age, gender, availability of media, etc.) when figuring out what types of materials to use.

CONSIDER BUDGET

Do you have a budget to invest in advertising or printing? If so, certain materials from this toolkit will be more useful than others. If not, you'll want to stick to the materials that work best for a no-budget campaign.

POCKET GUIDES FOR PRESCRIBERS & PHARMACISTS

Download, print and laminate these pocket guides. Then carry them with you, post them near your workstation or keep them in other convenient places when you're considering prescribing and dispensing decisions.

Download, print and distribute this brochure about prescription opioid safety and safe medication storage and disposal.

POSTER: WE CHECK K-TRACS

Download, print and hang these posters to let patients know that you actively use K-TRACS. Posters feature physicians, dentists and pharmacists to coordinate with all types of K-TRACS users.
