ORDER OF LICENSE REINSTATEMENT

This matter comes before the Board this 31 day of
March, 1995, at 2:30 P.M. at the Clubhouse Inn Meeting
Room, 515 S. Webb, Wichita, Kansas, on the Motion of Defendant
for Licensure Reinstatement. The State Board of Pharmacy
appears by Hoyt Kerr, President and Presiding Officer;
Glen Mathis, Vice-President; Dana Creitz, Pharmacist;
Monte Baugher, Pharmacist; Charlotte Brock, Pharmacist;
and Dr. Margaret Young, Consumer Representative. Also
appearing are Tom C. Hitchcock, Executive Secretary, and
the attorney for the Board, Dana W. Killinger. Defendant,
Cynthia Aguiar-Andreozzi appears in person. Also appearing
on behalf of the CIPP Committee is Etta Williams, and
as a friend of Cynthia Andreozzi is Ms. Shirley Keefer.

After hearing statements of Defendant, Cynthia Aguiar-Andreozzi, Etta Williams and Shirley Keefer, the Board finds that Defendant's license should be reinstated with certain restrictions and conditions.

IT IS THE ORDER of the Board as follows:

- 1. That Defendant's license be reinstated on the completion of 30 hours continuing education (30 Hours CE units) by July 1, 1995.
- 2. That Defendant be placed on probation for a period of Five (5) years.
- 3. That as a condition of the probation, Defendant renew her contract with the CIPP Committee for Five (5) years and cooperate with all requirements of said committee including but not limited to random drug screening, participation in and with support groups and attendance of any and all meetings with the CIPP program.
- 4. Defendant shall pay the costs herein as a condition of probation pursuant to K.S.A. 65-1627h. Failure to adhere to any of the requirements of probation may result in revocation of Defendant's license.

Pursuant to K.S.A. 77-526 the Defendant is advised of the following administrative remedies:

- (A) The Defendant, Cynthia Aguiar-Andreozzi, may file a Petition for Reconsideration, Fifteen (15) days after the service of the Order of License Reinstatement on the Defendant by the Agency Head, K.S.A. 77-529.
- (B) If no Petition for Review by a party or the President, Hoyt Kerr is filed, or a Petition for Reconsideration

is filed, the Order becomes effective Thirty (30) days after service on the Defendant, K.S.A. 77-530.

- (C) The Defendant may submit to the Presiding Officer or Board President a Petition for the Presiding Officer for a stay, pursuant to K.S.A. 77-528 until such time in which a Petition for Judicial Review would no longer be timely.
- (D) The Defendant has Thirty (30) days from the service of the Final Order to file a Petition for Judicial Review, K.S.A. 77-613.

FINAL ORDER

This matter comes for Formal Hearing on this 29th day of October, 1993.

The State Board of Pharmacy appears by Charlotte

Brock, President and Presiding Officer; Hoyt Kerr, Vice
President; Dana Creitz, Pharmacist; Monte Baugher, Pharmacist;

Glen Mathis, Pharmacist; and Dr. Margaret Young, Consumer

Representative. Also appearing are Tom C. Hitchcock,

Executive Secretary, and the attorney for the Board, Dana

W. Killinger. The Defendant, Cynthia Aguiar-Andreozzi

appears in person.

Thereupon attorney for Plaintiff introduced evidence of serving upon Defendant a Request for Admissions as set out in the PreHearing Order of August 27, 1993, Exhibit A. Said Exhibit was accepted into evidence. Attorney for the Board advised the Board that Defendant had made no response to the Request for Admissions, and therefore,

the Defendant had, in effect, admitted to all the Counts of the Petition, attorney for the plaintiff so rested his case.

After hearing testimony of Defendant and the testimony of Etta Williams, the Board went into Executive Session for quasi-judicial reasons to make finding of facts and law.

FINDING OF FACTS AND LAW

The Board finds that Defendant, Cynthia Aguiar-Andreozzi, by failing to respond to the Request for Admissions, in effect, admits to the facts and violations of law contained in Counts I through XXV of the Petition.

IT IS THEREFORE THE ORDER OF THE BOARD that pursuant to K.S.A. 65-1627(a)(3)(5)(6) & (8) and K.S.A. 65-4118 (a)(3) and K.S.A. 65-4119(a) the license of Defendant, Cynthia Aguiar-Andreozzi, License No. 11744 is revoked and Defendant to pay the costs herein.

Pursuant to K.S.A. 77-526(c) the Defendant is advised of the following administrative remedies:

- A. This Order signed and issued by the Presiding Officer who is also President and Agency Head of the State Board of Pharmacy of the State of Kansas is the Final Order pursuant to K.S.A. 77-526(a).
 - B. Pursuant to K.S.A. 77-529, Defendant has Fifteen

- (15) days from service of the Final Order to file a Petition upon the Agency Head, for reconsideration.
- C. Pursuant to K.S.A. 77-528, Defendant may submit a petition on the Agency Head for a stay of the Final Order.
- D. If no action is taken on the Petition for Reconsideration within Twenty (20) days from filing, the Petition is deemed denied, K.S.A. 77-529(b), and the Defendant has Thirty (30) days to file a Petition for Judicial Review, K.S.A. 77-613.
- E. Defendant may make application for reinstatement of her license to practice pharmacy One (1) year from the effective date of this Final Order, K.S.A. 65-1627a.

ORDER OF EMERGENCY SUSPENSION

This matter comes before the State Board of Pharmacy of the State of Kansas this 17th day of April, 1993.

The State Board of Pharmacy appears by Dana Creitz, President and Presiding Officer; Charlotte Brock, Vice-President; Kathleen Mahanna, Pharmacist; Barbara Renick, Pharmacist; Hoyt Kerr, Pharmacist; and Dr. Margaret Young, Consumer Representative. Also appearing are Tom C. Hitchcock, Executive Secretary, and the attorney for the Board, Dana W. Killinger. Cynthia Aguiar-Andreozzi did not appear.

Thereupon the attorney for the Board states that very recently evidence has come before the Executive Secretary, Tom C. Hitchcock, of such a nature that there may exist grounds pursuant to K.S.A. 65-4119(b) and K.S.A. 77-536 to hold an emergency hearing for the purpose of protecting the health and welfare of the public.

The attorney for the Board introduced evidence that

Attorney for the Board then called as witnesses,

Tom C. Hitchcock, Executive Secretary of the State Board

of Pharmacy of the State of Kansas, David Haws, Loss Prevention

Manager for Treasury Drug and Etta Williams of the Kansas

CIPP Committee and introduced certain exhibits.

After closing statement by counsel for the Board, the Board went into executive session for quasi-judicial reasons to consider finding of facts and possible imposition of appropriate sanctions.

After returning to open session, the Board President and Presiding Officer, Dana Creitz, made the following findings of fact and conclusions of law:

- 1. That Cynthia Aguiar-Andreozzi is a duly licensed pharmacist in the State of Kansas.
- 2. That this hearing is being conducted pursuant to K.S.A. 65-4119(b) and K.S.A. 77-536.
- 3. That based on the testimony of Etta Williams an emergency exists which is a danger to the public health, safety and welfare.
- 4. That based on the testimony of David Haws and the exhibits introduced, there is substantial evidence that Cynthia Aguiar-Andreozzi forged and diverted prescription

drugs for herself and her husband at Treasury Drugs #7721, 13511 S. Murlen, Suite 129, Olathe, Kansas, 66062, to wit:

IT IS ORDERED that the pharmacy license of Cynthia

Aguiar-Andreozzi, License No. 11744 is hereby temporarily suspended until the August 27, 1993, Board Meeting at which time a Formal Hearing shall take place.

That Cynthia Aguiar-Andreozzi by this ORDER is hereby noticed that future notices to the above address shall be sufficient notice to Cynthia Aguiar-Andreozzi pursuant to the Pharmacy Act and/or the Administrative Practices Act of the State of Kansas and should Cynthia Aguiar-Andreozzi fail to notify the Board's office of her change of resident address, such shall not be a defense for lack of service and the Board may take action be default for Cynthia Aguiar-Andreozzi's failure to appear.

IT IS FURTHER ORDERED that the Board's attorney file an Order to Show Cause under K.S.A. 65-4118(a)(3) and a Formal Petition under K.S.A. 65-1627(a)(3)(5) and (8).
