#### SUMMARY ORDER OF DENIAL

NOW, on this 18th day of February 2021, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Jill Clyce ("Applicant"), for application for a Kansas pharmacy technician registration.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board's Executive Secretary enters this Summary Order of Denial in the above-captioned matter. After reviewing the application materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

### FINDINGS OF FACT

1. On May 15, 2020, the Board received Applicant's application for registration as a pharmacy technician in the State of Kansas ("Applicant's Application").

2. As part of the application, Applicant answered "YES" to the question: *Have you ever been convicted of (includes plea of guilty or no contest) a criminal offense or is there any criminal charge now pending against you (other than minor traffic violations) in any state or federal court whether or not a sentence was imposed, suspended, or diverted? This includes misdemeanors.* The application directs that if the applicant answers yes, the applicant must attach a Form S-150: Personal History ("S-150").

3. On her S-150, Applicant disclosed a 2007 charge for refusal to breathalyze, for which she noted having successfully completed a 2-year supervised probation, a 1-year license suspension, several classes, and payment of fines. Applicant included no supporting documentation.

4. Subsequently, the Board received information regarding additional charges for misdemeanor theft/larceny in 2009, and for welfare fraud in 2013.

5. On May 28, 2020, the Board sent an letter to Applicant's email address of record requesting a more thorough S-150 to includes these new charges, as well as certified copies of the court pleadings from *all* cases.

6. On June 17, 2020, the Board received a brief email statement from Applicant that she couldn't recall the charges in question, but that "providing the documents requested in [the Board's] email is [her] most important and top priority."

7. On June 29, 2020, the Board received an email request from Applicant for extension of the deadline by which to submit the requested documentation. The Board immediately granted Applicant this extension, with her deadline to submit the requested documentation moved to July 31, 2020.

8. On October 6, 2020, as Applicant had still not submitted the requested documents, the Board sent a second request to Applicant's email address of record again requesting the more thorough S-150 and supporting court documents.

9. On November 24, 2020, the Board emailed a final request to Applicant's email address of record once more requesting these documents.

10. To date, the Board has received from Applicant neither a more thorough S-150, nor any supporting court documentation as requested. The Board has received no further correspondence from Applicant since she requested and was granted extension on June 29, 2020.

#### CONCLUSIONS OF LAW

1. That pursuant to K.S.A. 65-1663 the Board may limit, suspend, or revoke a registration or deny an application for issuance or renewal of any registration as a pharmacy technician on any ground which would authorize the Board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.

2. That pursuant to K.S.A. 65-1627 (a)(15), the Board may take action against the license of a pharmacist if the licensee has failed to furnish the board, its investigators or its representatives any information legally requested by the board.

3. Applicant's failure to supply the Board with the requested documentation is a violation of K.S.A. 65-1627(a)(15) and a basis to deny Applicant's Application.

### <u>ORDER</u>

Based upon the foregoing findings of fact and conclusions of law, Applicant's Application is hereby DENIED.

#### NOTICES

The Applicant is hereby notified as follows:

1. The Applicant may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.

2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.

3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is:
