SUMMARY ORDER OF DENIAL

NOW on this 18th day of December, 2023, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Roslyn Colum ("Applicant"), for application for a Kansas pharmacy technician registration.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board's Executive Secretary enters this Summary Order of Denial in the above-captioned matter. After reviewing the investigation materials and being otherwise duly advised in the premises, makes the following findings, conclusions and order:

FINDINGS OF FACT

1. On August 16, 2023, the Board received Applicant's application for registration as a pharmacy technician in the State of Kansas ("Applicant's Application").

2. As part of the application, Applicant answered "No" to the question: "Have you ever been convicted of (includes plea of guilty or no contest) a criminal offense or is there any criminal charge now pending against you (other than minor traffic violations) in any state or federal court whether or not a sentence was imposed, suspended, or diverted? This includes misdemeanors." The application directs that if the applicant answers yes, the applicant must attach a Form S-150: Personal History.

3. The Board received information regarding the following offenses: May 2003 Driving under influence of alcohol or drugs; Misdemeanor offense. March 2006 Municipal/county violation; traffic offense, driving while suspended; 2nd subsequent conviction and Vehicles; Liability insurance coverage required 2nd viol w/in 3 years offenses. September 2006 Municipal/county violation; Other offense and Failure to appear offense. March 2007 Failure to appear and Warrant arrest offenses. September 2007 Municipal/county violation; other offense and Warrant arrest offense. December 2007 Arrest by LEO; Warrant arrest and Municipal/county violation; Other offense(s). November 2008 Obstructing legal process or official duty; Resist Arrest, Arrest by LEO; Warrant arrest offense. April 2009 Arrest by LEO; Warrant arrest offense. June 2010 Arrest by law enforcement officer offense. April 2011 Arrest by LEO; Warrant arrest and obstructing legal process or official duty offenses. September 2012 Failure to appear offense. August 2014 Failure to appear offense. July 2018 Possession of stolen property; Misdemeanor offense. November 2019 Aggravated battery; Unknown circumstance and Criminal damage to property; Felony offenses.

4. On August 21, 2023, the Board sent a letter to Applicant's address of record requesting a completed Personal History Form S-150, as well as certified copies of the court pleadings from each case.

5. On August 28, 2023, the Board received returned mail marked non deliverable for Respondent's address of record. The Board emailed Respondent a copy of the letter as a courtesy.

6. On September 21, 2023, the Board sent a second letter and email to Applicant's address of record requesting this information.

7. On November 2, 2023, the Board mailed and emailed a Final Notice to Applicant's address of record requesting this information.

8. To date, the Board has not received a completed S-150 Personal History form from Applicant or any correspondence.

CONCLUSIONS OF LAW

1. That pursuant to K.S.A. 65-1663 the Board may limit, suspend, or revoke a registration or deny an application for issuance or renewal of any registration as a pharmacy technician on any ground which would authorize the board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.

2. That pursuant to K.S.A. 65-1627 (a)(15), the Board may take action against the license of a pharmacist if the licensee has failed to furnish the board, its investigators or its representatives any information legally requested by the board.

3. Applicant's failure to supply the Board with the requested documentation is a violation of K.S.A. 65-1627(a)(15) and a basis to deny Applicant's Application.

<u>ORDER</u>

Based upon the foregoing findings of fact and conclusions of law, Applicant's Application is hereby DENIED.

NOTICES

The Applicant is hereby notified as follows:

1. The Applicant may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.

2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.

3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is:
