SUMMARY ORDER OF DENIAL

NOW, on this 5th day of August 2021, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Valentina Hendrix ("Applicant"), for application for a Kansas pharmacy technician registration.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, et seq., and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, et seq., the Board's Executive Secretary enters this Summary Order of Denial in the above-captioned matter. After reviewing the application materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions, and order:

FINDINGS OF FACT

1. On February 26, 2021, the Board received Applicant's application for registration as a pharmacy technician in the State of Kansas ("Applicant's Application").

2. As part of the application, Applicant answered "YES" to the questions: Have you ever been convicted of (includes plea of guilty or no contest) a criminal offense or is there any criminal charge now pending against you (other than minor traffic violations) in any state or federal court whether or not a sentence was imposed, suspended, or diverted? This includes misdemeanors and Is there any disciplinary action pending against you by any licensing jurisdiction, the USDA, DEA, or any other federal or state drug enforcement agency? and Have you ever been charged with or convicted of (includes plea of guilty or not contest) a violation of

*any federal or state drug law(s) or rule(s) whether or not a sentence was imposed, suspended, or diverted?* The application directs that if the applicant answers “YES”, the applicant must attach a Form S-150: Personal History (“Form S-150”).

3. On her Form S-150, Applicant state only “pending case from 12/28/2020.” Applicant included no supporting court documentation.

4. On March 4, 2021, the Board received information regarding charges laid against Applicant, on the date she disclosed, for distribution of hallucinogenic/marijuana and for distribution of opiates/opium/narcotics/stimulant.

5. On March 4, 2021, the Board sent a letter to Applicant’s address of record requesting a more thorough Form S-150, as well as certified copies of the court pleadings from the case. Applicant did not respond to the Board’s request.

6. On April 8, 2021, the Board sent a second letter to Applicant’s address of record again requesting this same information. Applicant did not respond.

7. On July 8, 2021, the Board mailed a final letter to Applicant’s address of record requesting this information one last time. Applicant did not respond.

8. To date, the Board has not received a more thorough Form S-150 or any court documents from Applicant, nor any correspondence.

#### CONCLUSIONS OF LAW

1. Pursuant to K.S.A. 65-1663 the Board may deny an application for issuance of any registration as a pharmacy technician on any ground which would authorize the Board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.

2. Pursuant to K.S.A. 65-1627 (a)(15), the Board may take action against the license of a pharmacist if the licensee has failed to furnish to the Board, its investigators, or its representatives any information legally requested by the Board.

3. Applicant's failure to supply the Board with the requested documentation concerning her distribution charges is a violation of K.S.A. 65-1627(a)(15) and a basis to deny Applicant's Application.

#### ORDER

Based upon the foregoing findings of fact and conclusions of law, Applicant's Application is hereby DENIED.

#### NOTICES

The Applicant is hereby notified as follows:

1. The Applicant may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.

2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.

3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is:


