EX PARTE EMERGENCY ORDER OF SUSPENSION

NOW on this 2 day of Agost, 2012, this matter comes before the Investigative Member of the Kansas State Board of Pharmacy on a Motion for Ex Parte Emergency Order of Suspension in the matter of James Latta ("Respondent"). On August 23, 2012, the Compliance Counsel for the Board ("Petitioner") filed a Motion for Ex Parte Emergency Order of Suspension. Upon review of the Motion, the Investigative Member finds, concludes and orders the following:

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- The Board has previously issued Respondent License No. 1-15385 which entitled him to practice pharmacy in the State of Kansas.
- Pursuant to K.S.A. 65-1627 and 77-536, the Investigative Member may issue an
 emergency order without notice and hearing, and may temporarily limit or suspend a
 registration if the Investigative Member finds an imminent danger to the public
 health, welfare, or safety.

- The Investigative Member has received and reviewed a Motion for Ex Parte
 Emergency Order of Suspension filed with the Board on August 23, 2012. The
 motion requests an emergency suspension of Respondent's license.
- 4. The aforementioned motion alleges that Respondent is in violation of the Kansas Pharmacy Act:
 - a. Respondent self-reported to the Committee on Impaired Pharmacy Practice
 (CIPP) on or about July 13, 2012.
 - b. As a prerequisite to his CIPP participation, Respondent underwent an initial evaluation with Professional Treatment Services in Lawrence, KS, on or about July 16, 2012.
 - c. Respondent's initial evaluation indicated a substance abuse problem, and recommended further participation in the CIPP program and enrollment in an intensive outpatient therapy program.
 - d. On or about July 29, 2012, Respondent admitted to fraudulently adding refills to a prescription for Tussinex, and was terminated from his employment with Walgreens Pharmacy #7778 in Topeka, KS.
 - e. As a result of this arrest, Respondent was reported to the Board, and case number 12-116 was opened.
 - f. After some delay, Respondent completed and submitted the required forms to CIPP, officially enrolling himself in the program on August 9, 2012.
 - g. As of this date, Respondent has yet to enroll in the intensive outpatient therapy program as required by his CIPP agreement.

- h. Respondent's actions, in combination with his evaluation, indicate that he is currently unfit for the practice of pharmacy.
- i. On August 14th, 2012, the Board sent Respondent a Consent Agreement requesting that he voluntarily surrender his license until he had progressed farther along in his treatment with CIPP.
- j. On August 22, 2012, the Board attempted to contact Respondent via telephone and email to inform him that if he did not respond to the Consent Agreement, the Board would need to file an Emergency Order of Suspension against his license.
- k. As of the date of this Motion, Respondent has yet to respond to the Board's
 Consent Agreement, or to the phone call and email of August 22, 2012.
- By failing to respond to the reasonable requests of both CIPP and the Board,
 Respondent has failed to sufficiently comply with the directives of CIPP and thus is in noncompliance with his CIPP contract.
- m. Respondent has also violated K.S.A. 65-1627(a)(3), further defined by K.S.A. 65-1626(rr), in that he has committed conduct likely to deceive, defraud or harm the public.
- n. Respondent has also violated K.S.A. 65-1627(a)(4), in that he has shown to be addicted to a liquor or drug habit to such a degree as to render the Respondent unfit to practice the profession of pharmacy.
- 5. For the reasons specified in Paragraph 4, the Investigative Member finds that Respondent is an imminent danger to the public health, safety and welfare.

ORDER

IT IS THEREFORE ORDERED, that the pharmacist license of James Latta is hereby immediately suspended.

IT IS FURTHER ORDERED, that Respondent shall authorize CIPP, the Board and any provider of evaluation or treatment services to provide full and complete documentation and information regarding Respondent's involvement in the programs.

IT IS FURTHER ORDERED, that the Board counsel shall serve this Order in the manner provided by law, and shall complete and file a proof of service.

IT IS FURTHER ORDERED, that a protective order is granted to protect all confidential information under K.S.A. 65-1695.

NOTICE

- A hearing on this matter will be scheduled as soon as practicable before the Board of Pharmacy. The issue to be determined shall be whether Respondent's suspension should remain in place, be modified or terminated. A Notice of Hearing will be issued.
- 2. This is an emergency order. An emergency order is effective when rendered. A party to an agency proceeding may seek judicial review of an emergency order by filing a petition in the district court pursuant to K.S.A. 77-601, et seq. A petition for judicial review is not timely unless filed within 30 days of the service of this order. A copy of any petition for judicial review must be served upon the Board's Executive Director, at 800 SW Jackson, Ste. 1414, Topeka, KS 66612.
