These costs may include charges for services rendered by the Board's disciplinary counsel, an administrative law judge, and, if applicable, a court reporter.

SUMMARY ORDER

NOW, on this 11th day of May 2023, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Jennifer Manyseng, ("Applicant"), for application for registration as a Kansas pharmacy technician.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board's Executive Secretary enters this Summary Order in the above-captioned matter. After reviewing the application materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order.

FINDINGS OF FACT

- 1. On February 13, 2023, the Board received Applicant's application for registration as a pharmacy technician in the State of Kansas ("Applicant's Application").
- 2. Applicant answered "No" to the following question on her application: "Have you been charged with or convicted of (includes plea of guilty or no contest) a criminal offense or is there any criminal charge now pending against you (other than minor traffic violations) in any state or federal court whether or not a sentence was imposed, suspended, or diverted? This includes misdemeanors." The application directs that if the applicant answers yes, the applicant must attach a Form S-150: Personal History ("Form S-150").

- 3. In conjunction with Applicant's Application, she provided an S-150 statement which read "2018 DUI on diversion" and "2022 DUI pending."
- 4. The Board received information regarding a September 2018 misdemeanor driving under influence of alcohol or drugs offense, and a November 27, 2022 felony driving under the influence of alcohol or drugs offense against Applicant.
- 5. On February 15, 2023, the Board mailed Applicant a letter requesting a completed Form S-150, as well as certified copies of the court pleadings from each case.
- 6. On March 2, 2023, the Board received a copy of a court document related to the 2018 DUI, which indicated Applicant completed a diversion for that offense.
- 7. On March 7, 2023, the Applicant emailed the Board requesting an extension of time to provide the remainder of the requested documentation, which was granted.
- 8. On or about March 16, 2023, the Board received the requested documentation, which indicated Applicant's 2022 DUI offense was scheduled for sentencing on May 1, 2023. Applicant also provided several letters of support, including one from the store manager.

CONCLUSIONS OF LAW

- 1. Pursuant to K.S.A. 65-1658, the Board may assess a civil fine not to exceed \$5,000, after notice and an opportunity to be heard, to any registrant for violation of the pharmacy act of the state of Kansas or any other rules or regulations of the state board of pharmacy.
- 2. That pursuant to K.S.A. 65-1663, the Board may limit, suspend, or revoke a registration or deny an application for issuance or renewal of any registration as a pharmacy technician on any ground which would authorize the board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.

- 3. Pursuant to K.S.A. 65-1627(a)(1), the Board may take action against the license of any pharmacist upon a finding that the licensee has obtained, renewed or reinstated, or attempted to obtain, renew or reinstate, a license by false or fraudulent means, including misrepresentation of a material fact.
- 4. Pursuant to K.S.A. 65-1627(a)(3), the Board may place in a probationary status the license of any pharmacist who has been found guilty of unprofessional conduct.
- 5. Pursuant to K.S.A. 65-1626(vvv)(7), unprofessional conduct means conduct likely to deceive, defraud or harm the public.
- 6. Applicant's answer of "no" to the disciplinary question(s) on Applicant's Application was a misrepresentation of material fact on an application and a basis to take action against Applicant's Application as a violation of K.S.A. 65-1627(a)(1).
- 7. Applicant's repeated DUI offenses and pending sentencing and court requirements are unprofessional conduct likely to harm the public and a basis to place Applicant's registration in a probationary status pursuant to K.S.A. 65-1627(a)(3) in order to ensure additional oversight and supervision by the supervising pharmacist(s).

<u>ORDER</u>

Based upon the foregoing findings of fact and conclusions of law, Applicant's Application for issuance of pharmacy technician registration is hereby GRANTED subject to a 2-year probationary status and payment of a fine to the Board in the amount of \$200. Applicant has 30 days from the date of this order to pay the fine and the probationary pharmacy technician registration shall be issued upon receipt. The terms of Applicant's probation are as follows:

 Applicant must comply with the terms of any court-imposed sentence related to the 2022 DUI offense;

- Applicant must notify the Board of any change in their court status within 10 days of the change;
- Applicant must notify the Board of any arrest or criminal charge within 10 days of the date of the arrest or charge;
- Applicant must notify the Board of any change in employment within 10 days of the change;
- Applicant must respond to the Board's regular check-in requests;
- Applicant must inform employers of the probationary status of their pharmacy technician registration;
- Applicant must obtain the signature of their pharmacist-in-charge (PIC) documenting knowledge of her probationary status to the Board; and
- Applicant must comply with all rules and regulations of the Pharmacy Practice
 Act.

NOTICES

Applicant is hereby notified as follows:

- Applicant may request a hearing pursuant to the Kansas Administrative Procedure
 Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414,
 Topeka, KS 66612-1231 within fifteen (15) days after service of this order.
- 2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.
- 3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is
