#### **SUMMARY ORDER OF REVOCATION**

NOW on this 26th day of April 2023 comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Bryce Money ("Respondent").

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board's Executive Secretary enters this Summary Order of Revocation in the abovecaptioned matter. After reviewing the investigation materials and being otherwise duly advised in the premises, makes the following findings, conclusions, and order:

## FINDINGS OF FACT

1. The Board has issued Respondent Pharmacy Technician Registration Number 24-114457 authorizing Respondent to perform the functions of a pharmacy technician in the State of Kansas ("Respondent's Registration").

2. On or about January 20, 2022, the Board received information concerning Applicant's arrest on January 16, 2022 and charges files on January 25, 2022 for the following offenses: felony aggravated burglary, dwelling for felony, theft, sex; felony aggravated domestic battery, choke in a rude manner, family member/dating relationship; misdemeanor attempted domestic battery, knowing rude physical contact with family member or dating relationship; misdemeanor battery; and felony aggravated kidnapping.

3. On January 20, 2022, the Board sent a letter to Respondent's address of record requesting a completed Personal History Form S-150, as well as certified copies of the court pleadings from each case.

4. On February 1, 2022, the Board received an S-150 Personal History Form from the Respondent explaining the aforementioned charges, and providing court documents confirming the charges.

5. On October 17, 2022, the Board sent a letter to Respondent's address of record requesting a status update on the pending charges by October 31, 2022.

6. On February 23, 2023, the Board mailed a Final Notice to Respondent's address of record requesting this information.

7. On March 3, 2023, the Board received a notice of returned mail, unable to forward from the US Postal Service in regard to the Board's February 23, 2023 letter. The Board sent Respondent an email requesting an updated mailing address.

8. To date, the Board has not received any correspondence from the Respondent or response to the request for an update regarding Respondent's pending criminal charges.

## CONCLUSIONS OF LAW

1. That pursuant to K.S.A. 65-1663 the Board may limit, suspend, or revoke a registration or deny an application for issuance or renewal of any registration as a pharmacy technician on any ground which would authorize the board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.

2. That pursuant to K.S.A. 65-1627 (a)(15), the Board may take action against the license of a pharmacist if the licensee has failed to furnish the board, its investigators, or its representatives any information legally requested by the board.

3. Respondent's failure to supply the Board with the requested documentation is a violation of K.S.A. 65-1627(a)(15) and a basis to revoke Respondent's Registration.

#### <u>ORDER</u>

Based upon the foregoing findings of fact and conclusions of law, Respondent's Registration is hereby REVOKED.

#### **NOTICES**

The Respondent is hereby notified as follows:

1. The Respondent may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.

2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.

3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is:
