FINAL AGENCY ORDER

On July 25, 2014, the Kansas Board of Pharmacy (the "Board") held a hearing on the allegations that Lynn T. Nguyen ("Nguyen"), while acting as a pharmacy technician stole controlled substances from her employer. Nguyen did/did not appear in person. Randall J. Forbes of Frieden, Unrein & Forbes, LLP appeared as the Board's Disciplinary Counsel. After considering the evidence admitted at the hearing, the Board enters the following final agency order.

I. FINDING OF FACT

1. The Board previously issued Nguyen Kansas Pharmacy Technician registration number 14-14512, which entitled her to engage in the practice of a pharmacy technician in the State of Kansas.

2. On February 26, 2014, Nguyen signed a written statement admitting that while acting as a pharmacy technician at the Walgreen at 5505 E. Harry in Wichita, Kansas she stole 3,000 Hydrocodone-APAP 10-500 tablets, 4,000 Hydrocodone-APAP 10-325 and approximately 15 bottles of promethazine. As a result of her theft, Nguyen was in unlawful possession of those drugs.

II. CONCLUSIONS OF LAW AND FACT

1. Pursuant to K.S.A. 65-1663(e)(1) the Board may take disciplinary action, including revocation, against the registration of a pharmacy technician on any grounds which would authorize the Board to take action against the license of a pharmacist under K.S.A. 65-1627 and amendments thereto.

2. Pursuant to 65-1627(a)(3), the Board can take disciplinary action against the Kansas license of a pharmacist for unprofessional conduct. Pursuant to K.S.A. 65-1626 (ccc)(5), unprofessional conduct includes the unlawful possession of drugs.

3. As a result of Nguyen's theft of drugs from her employer, she is guilty of the unlawful possession of drugs and the Board can revoke her Kansas pharmacy technician registration.

III. FINAL ORDER

Based upon the evidence introduced at the hearing held July 25, 2014 and the foregoing findings and conclusions, Nguyen's Kansas pharmacy technician registration is hereby REVOKED.


Within fifteen (15) days after service of this Final Agency Order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

Within the time limits established in K.S.A. 77-613, either party may seek judicial review of this Final Agency Order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is:


