STIPULATION OF FINDING OF FACT AND ORDER

This matter comes before the State Board of Pharmacy of the State of Kansas, this 5th day of November, 1994.

The State Board of Pharmacy appears by Hoyt Kerr, President and Presiding Officer; Glen Mathis, Vice-President; Dana Creitz, Pharmacist; Monte Baugher, Pharmacist; Charlotte Brock, Pharmacist; and Dr. Margaret Young, Consumer Representative. Also appearing are Tom C. Hitchcock, Executive Secretary, and the attorney for the Board, Dana W. Killinger. Donald K. Pohl appears in person.

Donald K. Pohl states that he has been advised of his procedural rights under the Pharmacy Practice Act and Administrative Procedure Act, wherein Donald K. Pohl has the right to a formal hearing, a right to be represented by counsel, call witnesses on his behalf, cross-examine the Board's witnesses and other procedural rights.

Donald K. Pohl, License No. 10652, acknowledges that he understands the various rights and privileges afforded him by law, including the right to appear and be represented

by legal counsel, the right to have all charges against him proven upon the record by competent and substantial evidence; the right to cross-examine any witnesses appearing at the hearing against him; and a hearing before the State Board of Pharmacy. Being aware of these rights provided him by operation of law, Donald K. Pohl, knowingly and voluntarily waives each and every one of these rights, and freely enters into this Joint Stipulation of Facts, and waives hearing before the State Board of Pharmacy.

2. That Donald K. Pohl is a licensed pharmacist in the State of Kansas, having License No. 10652.

3. That Donald K. Pohl was also licensed by the California State Board of Pharmacy having California License #40550.

4. That on or about March 21, 1994, said Donald K. Pohl's California Pharmacy license was revoked by the California State Board of Pharmacy. (See Exhibit A)

5. That pursuant to K.S.A. 65-1627(a)(12) the State Board of Pharmacy of the State of Kansas has the power and authority to revoke suspend, or place on probation the license of Donald K. Pohl.

IT IS THEREFORE ORDERED that Donald K. Pohl, License No. 10652 be placed on Three (3) year probation with the State Board of Pharmacy of the State of Kansas, sign a new

contract with the CIPP Committee for Three (3) years. Mr. Pohl will report directly to Etta Williams of the Cipp Committee with the Illinois report. Mr. Pohl will sign a release with Etta Williams to release said information and report to the State Board of Pharmacy of the State of Kansas.
