**NOTICE OF PROPOSED DEFAULT ORDER
AND
PROPOSED DEFAULT ORDER**

The above-captioned matter comes on for consideration by the Kansas State Board of Pharmacy (Board) to enter a Proposed Default Order.


The Board finds:

1. On July 24, 2015, the Board issued a Petition to Revoke, Suspend or Otherwise Limit the pharmacy license of William L. Pollard, R.Ph.
2. On July 29, 2015, a Notice of Administrative Hearing was served on Mr. Pollard, setting the hearing in this matter for November 5, 2015 at 1:00 p.m.
3. The Notice of Administrative Hearing specifically provided that “[a]ny party who fails to attend or participate in the hearing or in any other portion of the adjudicative process may be held in default pursuant to K.S.A. 77-520 and the Board may conduct further proceedings necessary for adjudication without the participation of the Respondent.”
4. On August 3, 2015, a Notice of Prehearing Conference was served on Mr. Pollard, setting a prehearing in this matter for August 20, 2015 at 9:30 a.m.
5. The Notice of Prehearing Conference provided “[a]ny party who fails to attend or participate in a prehearing conference, hearing or other state of an adjudicative proceeding may be held in default pursuant to K.S.A. 77-520 of the Kansas Administrative Procedure Act.”
6. Mr. Pollard did not appear for the prehearing conference on August 20, 2015.
7. Mr. Pollard also did not appear for the hearing on November 5, 2015.
8. Mr. Pollard is in default pursuant to K.S.A. 77-520.

9. This Proposed Default Order shall become effective seven days after service or ten days after mailing of this order unless Mr. Pollard files a written motion with the Board at the address provided stating why the Proposed Default Order should be vacated and the order is then vacated.
10. If this Proposed Default Order becomes effective, the Board shall conduct further proceedings necessary for adjudication without the participation of Mr. Pollard.

The Board, being well and duly advised in the premises, now enters this Proposed Default Order against Mr. Pollard. It shall take effect as specified in the above findings.
