**SUMMARY ORDER OF REVOCATION**

NOW on this 13 day of February, 2019, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Trisha Stotts, Pharmacist ("Respondent").

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board's Executive Secretary enters this Summary Order of Revocation in the above-captioned matter. After reviewing the investigation materials and being otherwise duly advised in the premises, makes the following findings, conclusions and order:

**FINDINGS OF FACT**

For purposes of this order, the Board's Executive Secretary makes the following findings of fact:

1. The Board has previously issued Respondent Pharmacist License Number 1-12045 authorizing her to perform the functions of a pharmacist in the State of Kansas ("Respondent's License").
2. On or about April 4, 2018, the Board mailed Respondent a summary order imposing a fine of \$1,700.00 and 68 hours of continuing education (CE) for failure to complete

her required CE during an audited period. Respondent had 30 days from the date of the order to pay the fine and complete the additional CE.

3. On or about June 7, 2018, the Board mailed Respondent a demand letter for submission of the full payment and additional CE by June 22, 2018.

4. On or about September 7, 2018, the Board mailed Respondent a final demand letter for submission of the full payment and additional CE. This letter was returned to the Board as “not deliverable as addressed.”

5. On January 3, 2019, having receiving notification that Respondent did not receive the final demand letter issued on September 7, 2018, the Board re-mailed the final demand letter to the correct address for submission of the full payment and additional CE by January 18, 2019.

6. To date, the Board has not received the fine payment or the additional CE from Respondent.

#### CONCLUSIONS OF LAW

7. That pursuant to K.S.A. 65-1627(a)(16), the Board may revoke the license of any pharmacist upon a finding that the licensee has violated or failed to comply with any lawful order or directive of the board.

8. Respondent’s failure to pay the fine and complete the additional CE imposed is a failure to comply with a lawful board order and a basis to revoke Respondent’s License pursuant to K.S.A. 65-1627(a)(16).

#### ORDER

Based upon the foregoing findings of fact and conclusions of law, Respondent’s Registration is hereby REVOKED.

NOTICES

The Respondent is hereby notified as follows:

9. The Respondent may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.

10. If a hearing is not requested as described above, the Order revoking the Respondent's Pharmacist License shall become a final order of the Board, effective upon the expiration of the time to request a hearing.

11. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.




