These costs may include charges for services rendered by the Board's disciplinary counsel, an administrative law judge, and, if applicable, a court reporter.

SUMMARY ORDER

NOW, on this 20th day of December, 2023, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Tevin Taylor, ("Applicant"), for application for registration as a Kansas pharmacist intern.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board's Executive Secretary enters this Summary Order in the above-captioned matter. After reviewing the application materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order.

FINDINGS OF FACT

- 1. On September 5, 2023, the Board received Applicant's application for registration as a pharmacist intern in the State of Kansas ("Applicant's Application").
- 2. Applicant answered "No" to the following question on Applicant's Application: "Have you been charged with or convicted of (includes plea of guilty or no contest) a criminal offense or is there any criminal charge now pending against you (other than minor traffic violations) in any state or federal court whether or not a sentence was imposed, suspended, or diverted? This includes misdemeanors." The application directs that if the applicant answers yes, the applicant must attach a Form S-150: Personal History ("Form S-150").

- 3. The Board received information regarding an October 2019 driving under the influence of drugs/alcohol, 1st conv, blood/breath .08> and liquor offense, and a purchase/possess/consume by minor 18-20 yrs., unknown conviction offense against Applicant.
- 4. On September 11, 2023, the Board mailed Applicant a letter requesting a completed Form S-150, as well as certified copies of the court pleadings from each case.
- 5. On October 5, 2023, the Board received a request for additional time for Applicant to provide the requested documentation, which was granted.
- 6. On November 2, 2023, the Board received a request for additional time for Applicant to provide the requested documentation, which was granted.
- 7. On or about December 7, 2023, the Board received the requested documentation, which indicated Applicant completed a diversion for the offenses.

CONCLUSIONS OF LAW

- 1. Pursuant to K.S.A. 65-1658, the Board may assess a civil fine not to exceed \$5,000, after notice and an opportunity to be heard, to any registrant for violation of the pharmacy act of the state of Kansas or any other rules or regulations of the state board of pharmacy.
- 2. That pursuant to K.S.A. 65-1676(d), the Board may take action on an application for issuance of any registration as a pharmacist intern on any ground which would authorize the board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.
- 3. Pursuant to K.S.A. 65-1627(a)(1), the Board may take action against the license of any pharmacist upon a finding that the licensee has obtained, renewed or reinstated, or attempted to obtain, renew or reinstate, a license by false or fraudulent means, including misrepresentation of a material fact.

4. Applicant's answer of "no" to the disciplinary question(s) on Applicant's Application was a misrepresentation of material fact on an application and a basis to take action

against Applicant's Application as a violation of K.S.A. 65-1627(a)(1).

<u>ORDER</u>

Based upon the foregoing findings of fact and conclusions of law, Applicant's

Application is hereby GRANTED but Applicant is ordered to pay a fine to the Board in the

amount of \$200. Applicant has 30 days from the date of this order to pay the fine and the

registration shall be issued upon receipt.

NOTICES

Applicant is hereby notified as follows:

1. Applicant may request a hearing pursuant to the Kansas Administrative Procedure

Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414,

Topeka, KS 66612-1231 within fifteen (15) days after service of this order.

2. If a hearing is not requested as described above, the Order shall become a final

order of the Board, effective upon the expiration of the time to request a hearing.

3. Within fifteen (15) days after entry of a final agency order, either party may file

a petition for reconsideration pursuant to K.S.A. 77-529.

4. Within the time limits established in K.S.A. 77-613, either party may seek judicial

review of a final agency order, pursuant to said statute. The agency officer designated to receive
