**SUMMARY ORDER OF DENIAL**

NOW, on this 18th day of April 2022, comes before the Kansas Board of Pharmacy (the “Board”), through its Executive Secretary, the matter of Brittany Williams (“Applicant”), for application for a Kansas pharmacy technician registration.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board’s Executive Secretary enters this Summary Order of Denial in the above-captioned matter. After reviewing the application materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order.

**FINDINGS OF FACT**

1. On January 14, 2022, the Board received Applicant’s application for registration as a pharmacy technician in the State of Kansas (“Applicant’s Application”).
2. Applicant answered “Yes” to the following question on his application: Have you been charged with or convicted of (includes plea of guilty or no contest) a criminal offense or is there any criminal charge now pending against you (other than minor traffic violations) in any state or federal court whether or not a sentence was imposed, suspended, or diverted? This includes misdemeanors.

3. In conjunction with Applicant's Application, Applicant submitted an S-150 Personal History statement which did not explain any of Applicant's criminal offenses. Applicant also provided several court summaries. Applicant disclosed a September 2008 resisting arrest offense and a January 2021 assault on a security officer offense.

4. The Board received additional information regarding a January 2005 larceny of merch from retailer offense, a 2006 resisting arrest offense, and a September 2012 desertion of children under age 10 offense.

5. On January 20, 2022, the Board mailed Applicant a letter requesting a more thorough Personal History Form S-150, as well as certified copies of the court pleadings from each case.

6. Between February 11 and 22, 2022, the Board received the requested documentation. Applicant's personal statement and court documents confirmed that Applicant did not disclose all offenses on Applicant's Application.

7. On or about March 9, 2022, the Board's Individual License Evaluator conducted a phone interview with Applicant.

#### CONCLUSIONS OF LAW

1. That pursuant to K.S.A. 65-1663, the Board may limit, suspend, or revoke a registration or deny an application for issuance or renewal of any registration as a pharmacy technician on any ground which would authorize the board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.

2. Pursuant to K.S.A. 65-1627(a)(1), the Board may deny an application of any pharmacist who has obtained, renewed or reinstated, or attempted to obtain, renew or reinstate, a license by false or fraudulent means, including misrepresentation of a material fact.

3. Pursuant to K.S.A. 65-1627(a)(3), the Board may deny an application of any pharmacist who has been found guilty of unprofessional conduct.

4. Pursuant to K.S.A. 65-1626(uuu), unprofessional conduct means conduct likely to deceive or harm the public, and/or fraud in securing a registration.

5. Applicant's partial but incomplete disclosure of her criminal offense history on Applicant's Application was a misrepresentation of a material fact and a basis to deny Applicant's Application pursuant to K.S.A. 65-1627(a)(1).

6. Applicant's pattern and practice of criminal offenses over 15 years, combined with her overall failure to demonstrate consciousness or understand the seriousness of her wrongful conduct, as well as her misrepresentation of her criminal history are unprofessional conduct and a basis to deny Applicant's Application pursuant to K.S.A. 65-1627(a)(3).

#### ORDER

Based upon the foregoing findings of fact and conclusions of law, Applicant's Application is hereby DENIED.

#### NOTICES

Applicant is hereby notified as follows:

1. Applicant may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.

2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.

3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is
