SUMMARY ORDER

NOW, on this 14th day of February, 2023, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Ja'Nay Wilson, ("Applicant"), for application for registration as a Kansas pharmacy technician.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board's Executive Secretary enters this Summary Order in the above-captioned matter. After reviewing the application materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order.

FINDINGS OF FACT

- 1. On September 27, 2022, the Board received Applicant's application for registration as a pharmacy technician in the State of Kansas ("Applicant's Application").
- 2. Applicant answered "Yes" to the following question on her application: "Have you been charged with or convicted of (includes plea of guilty or no contest) a criminal offense or is there any criminal charge now pending against you (other than minor traffic violations) in any state or federal court whether or not a sentence was imposed, suspended, or diverted? This includes misdemeanors." The application directs that if the applicant answers yes, the applicant must attach a Form S-150: Personal History ("Form S-150").

- 3. On her S-150, Applicant reported that on November 23, 2019 she left her children at home and was charged with an abandon endanger child with intent to return offense. In addition, she provided several letters of recommendation.
- 4. On September 28, 2022, the Board mailed Applicant a letter requesting certified copies of the court pleadings from the case.
- 5. On or about October 6, 2022, the Board received the requested documentation, which indicated Applicant was convicted of the offense and was serving five-years of courtmandated community supervision, scheduled to be completed in October 2025.
- 6. On November 16, 2022, the Board requested a more detailed S-150 statement regarding the offense and a time when Applicant would be available for a phone interview.
- 7. On January 11, 2023, the Board sent a follow-up request after receiving no response to the November 2022 letter.
- 8. On January 13, 2023, the Board received an email response indicating Applicant's availability for a phone interview, which was subsequently conducted.

CONCLUSIONS OF LAW

- 1. That pursuant to K.S.A. 65-1663, the Board may limit, suspend, or revoke a registration or deny an application for issuance or renewal of any registration as a pharmacy technician on any ground which would authorize the board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.
- 2. Pursuant to K.S.A. 65-1627(a)(3), the Board may place in a probationary status the license of any pharmacist who has been found guilty of unprofessional conduct.
- Pursuant to K.S.A. 65-1626(vvv)(7), unprofessional conduct means conduct 3. likely to deceive, defraud or harm the public.

- 4. Pursuant to K.S.A. 65-1626(a)(15), the Board may take action against the license of a pharmacist if the licensee has failed to furnish the board, its investigators or its representatives any information legally requested by the board.
- 5. Applicant's ongoing community supervision and recency of her child endangerment offense demonstrate insufficient rehabilitation to warrant the public trust at this time without additional supervision in the pharmacy setting.
- 6. In addition, the Board requested information from Applicant in November 2022 and did not receive a response until mid-January 2023, nearly two months later.
- 7. These actions are unprofessional conduct likely to harm the public and are a basis to place Applicant's registration in a probationary status pursuant to K.S.A. 65-1627(a)(3) and (a)(15).

ORDER

Based upon the foregoing findings of fact and conclusions of law, Applicant's Application for issuance of pharmacy technician registration is hereby GRANTED subject to a 2-YEAR probationary status. The terms of Applicant's probation are as follows:

- Applicant must continue compliance with the terms of their court supervision;
- Applicant must notify the Board of any change in their court status within 10 days of the change;
- Applicant must notify the Board of any arrest or criminal charge within 10 days of the date of the arrest or charge;
- Applicant must notify the Board of any change in employment within 10 days of the change;
- Applicant must respond to the Board's regular check-in requests;

- Applicant must inform employers of the probationary status of their pharmacy

technician registration;

- Applicant must obtain the signature of their pharmacist-in-charge (PIC)

documenting knowledge of her probationary status to the Board; and

- Applicant must comply with all rules and regulations of the Pharmacy Practice

Act.

NOTICES

Applicant is hereby notified as follows:

1. Applicant may request a hearing pursuant to the Kansas Administrative Procedure

Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414,

Topeka, KS 66612-1231 within fifteen (15) days after service of this order.

2. If a hearing is not requested as described above, the Order shall become a final

order of the Board, effective upon the expiration of the time to request a hearing.

3. Within fifteen (15) days after entry of a final agency order, either party may file

a petition for reconsideration pursuant to K.S.A. 77-529.

4. Within the time limits established in K.S.A. 77-613, either party may seek judicial

review of a final agency order, pursuant to said statute. The agency officer designated to receive
