These costs may include charges for services rendered by the Board's disciplinary counsel, an administrative law judge, and, if applicable, a court reporter.

SUMMARY ORDER

NOW, on this 11th day of July, 2022, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of James Wood, ("Applicant"), for application for registration as a Kansas pharmacist by reciprocity.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, et seq., and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, et seq., the Board's Executive Secretary enters this Summary Order in the above-captioned matter. After reviewing the application materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order.

FINDINGS OF FACT

- 1. On March 28, 2022, the Board received Applicant's application for registration as a pharmacist in the State of Kansas by reciprocity ("Applicant's Application").
- 2. Applicant answered "No" to the following question on Applicant's Application: "Have you ever been charged or convicted (including a nolo contendere plea or guilty plea) of a felony or misdemeanor (other than minor traffic offenses) whether or not sentence was imposed, suspended, expunged, or whether you were pardoned from any such offense? If yes, provide details."

- 3. The Board received information regarding a September 2006 person, disorderly conduct, disturbing the peace, and dangerous weapons unlawfully carried offense(s) involving Applicant.
- 4. On March 30, 2022, the Board mailed Applicant a letter requesting a completed Form S-150: Personal History ("Form S-150"), as well as certified copies of the court pleadings from each case.
 - 5. On or about April 28, 2022, the Board received the requested documentation.
 - 6. Applicant's Application and Form S-150 included the following information:
 - a. Applicant attended Boston Pharmacy School which was interrupted by the 2006 offenses.
 - b. Applicant is currently licensed as a pharmacist in New Hampshire, Idaho and Delaware.
 - c. Applicant's court documents indicated he was charged in September 2006 with disorderly conduct, disturbing the peace, unlawfully carrying and possessing a dangerous weapon (taser), and littering. Applicant was 20-years-old at the time of the offense. Applicant's arrest bail was set at \$5,000 and he was placed on pretrial probation or which he served community service.

CONCLUSIONS OF LAW

- 1. Pursuant to K.S.A. 65-1658, the Board may assess a civil fine not to exceed \$5,000, after notice and an opportunity to be heard, to any registrant for violation of the pharmacy act of the state of Kansas or any other rules or regulations of the state board of pharmacy.
- 2. Pursuant to K.S.A. 65-1627(a)(1), the Board may take action against the license of any pharmacist upon a finding that the licensee has obtained, renewed or reinstated, or

attempted to obtain, renew or reinstate, a license by false or fraudulent means, including misrepresentation of a material fact.

3. Applicant's answer of "no" to the disciplinary question(s) on Applicant's Application was a misrepresentation of material fact on an application and a basis to take action against Applicant's Application as a violation of K.S.A. 65-1627(a)(1).

ORDER

Based upon the foregoing findings of fact and conclusions of law, Applicant's Application is hereby GRANTED subject to Applicant's successful completion of the MPJE examination and payment of a fine to the Board in the amount of \$750. Applicant has 30 days from the date of this order to pay the fine and the approval to test shall be issued upon receipt.

NOTICES

Applicant is hereby notified as follows:

- 1. Applicant may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.
- 2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.
- 3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.
- 4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is
