III. Update on Law Enforcement Access to PDMPs	Ms. Donaldson provided the committee with requested information on law enforcement access to PDMPs for other states. Ms. Blasi provided an overview of Senate Bill 279 for the committee.
IV. Update on Missouri PDMP Data Sharing	Ms. Blasi discussed a letter the Board has drafted to send to Missouri PDMP stakeholders stressing the importance of a change in Missouri law to allow for interstate data sharing.
V. Legislative Update	Ms. Blasi discussed pending legislation that may have an impact on the K-TRACS program and budget.
VI. Pharmacy Reporting Guidance Document	Ms. Donaldson provided an overview of a guidance document related to changes to how pharmacies report to K-TRACS.  Mr. Coble moved to approve the guidance document, seconded by Mr. Godwin. Motion approved.
VII. K-TRACS Usability Updates	Ms. Greene provided an overview of recent updates to K-TRACS to improve usability based on user feedback.
VIII. Prescriber E-Recap (PERx) and NarxCare Funding	Ms. Donaldson provided an overview of the Prescriber E-Recap (PERx) and recommended to the committee to discontinue use. Dr. Fain moved to discontinue use, seconded by Dr. Long. Motion approved.
