According to KSA 65-1627h, the Board is required to recoup the costs of administrative hearings when the decision is adverse to the licensee. These costs may include charges for services rendered by the Board's disciplinary counsel, an administrative law judge, and, if applicable, a court reporter.

AMENDED SUMMARY ORDER

NOW on this 30th day of March 2022, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Trenton Barton ("Respondent").

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, et seq., and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, et seq., the Board's Executive Secretary enters this Summary Order in the above-captioned matter. After reviewing the investigation materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

FINDINGS OF FACT

- 1. The Board has previously issued Respondent Pharmacist License No. 1-103206 ("Respondent's License"), authorizing Respondent to perform the functions of a pharmacist in the State of Kansas.
- 2. On or about November 17, 2021, the Board received information regarding charges laid against Respondent for incidents of domestic battery and of criminal damage to property.
- 3. Also on November 17, 2021, the Board sent a letter to Respondent's mailing address of record requesting a completed Personal History Form S-150 ("S-150"), as well as certified copies of the court pleadings from the case. Respondent did not respond.
- 4. On December 17, 2021, the Board sent a second letter to Respondent's mailing address of record again requesting the S-150 and court documents.

- 5. On December 20, 2021, Respondent emailed the Board to request additional time in which to submit his documents.
- 6. Also on December 20, 2021, since Respondent had until January 21st to submit said documents, the Board responded to Respondent's email, denying his request to extend such date.
- 7. On January 27, 2021, as the Board had not received the requested documents, the Board mailed a final letter to Respondent's mailing address of record, requesting the S-150 and court documents one final time.
- 8. On February 15, 2022, Respondent emailed the Board to again request an extension of his deadline by which to submit his documentation, which was now set for February 11, 2022.
- 9. The Board immediately replied to deny Respondent's email request, deeming the nearly 90 days it had given Respondent as a reasonable window of time in which to collect and submit his documents.
- 10. On February 23, 2022, the Board entered a Summary Order of Revocation against Respondent for failure to furnish to the Board the information legally requested.
- 11. On February 28, 2022, the Board received a timely request for hearing on the Summary Order as well as the requested documentation.

CONCLUSIONS OF LAW

- 1. Pursuant to K.S.A. 65-1658, the Board may assess a civil fine not to exceed \$5,000, after notice and an opportunity to be heard, to any registrant for violation of the pharmacy act of the state of Kansas or any other rules or regulations of the state board of pharmacy.
- 2. Pursuant to K.S.A. 65-1627(a)(15), the Board may take action against the license of any pharmacist if the licensee has failed to furnish the Board, its investigators, or its representatives any information legally requested by the Board.

3. Respondent's failure to supply the Board with the requested documentation within a reasonable time period is a violation of K.S.A. 65-1627(a)(15) and a basis to take action against Respondent's License.

ORDER

Based upon the foregoing findings of fact and conclusions of law, Respondent's License shall remain active but Respondent is ordered to pay a fine to the Board in the amount of \$1,000. Respondent has 30 days from the date of this order to pay the fine.

NOTICES

The Respondent is hereby notified as follows:

- 1. The Respondent may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.
- 2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.
- 3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.
- 4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is:
