AGREED FINAL ORDER OF SURRENDER OF KANSAS REGISTRATION

The Respondent, Tammy Boon (“Boon”), through her counsel, Peter Rumbold, and Disciplinary Counsel for the Kansas Board of Pharmacy, Brenda L. Head, have jointly requested that the Kansas Board of Pharmacy (“Board”) enter this Agreed Final Order of Surrender of Kansas Registration.

The parties have stipulated, and the Board finds as follows:

1. The Board has issued Respondent Pharmacy Technician Registration Number 14-103310 authorizing Respondent to perform the functions of a pharmacy technician in the State of Kansas (“Respondent’s Registration”).

2. At all times relevant hereto, Respondent worked as a pharmacy technician at Walmart Pharmacy #43, located at 521 East Chestnut Street in Junction City, Kansas (“the Pharmacy”).

3. On or about November 22, 2019, the Board received notification of the theft/loss of controlled substances from the Pharmacy, indicating that Respondent had been terminated from the Pharmacy on September 26, 2019, for suspected diversion of hydrocodone and oxycodone tablets, but that no police report had been filed.

4. Subsequently, the Board’s inspector conducted an investigation.

5. On December 26, 2019, the Board's investigator submitted to the Board her investigation report. The report found that Respondent had not admitted to taking the tablets, and had appealed her termination with the Pharmacy. The Pharmacy had maintained Respondent termination after Walmart's Global Ethics & Compliance team conducted an internal investigation. The internal investigation findings had, based on video footage and statements from coworkers, upheld that Respondent had indeed taken the tablets from the Pharmacy's will-call bags.

6. On January 24, 2020, the Board entered a Summary Order of Revocation in this matter based upon unprofessional conduct or professional incompetency as defined by K.S.A. 65-1626(uuu) and her disregard for the potential harmful effects of her actions to the public in violation of K.S.A. 65-1627(a)(3).

7. On February 11, 2020, through counsel, Boon requested a formal hearing.

8. On March 5, 2020, the Board acknowledged receipt of Boon's request for a formal hearing and Boon was notified of K.S.A. 65-1627h which assesses the costs of the hearing, as well as any fines imposed, to the plaintiff, if the Board's decision is not in her favor.

9. Boon wishes to conclude this matter by surrendering her Kansas Registration on the terms provided in this Order.


IT IS THEREFORE ORDERED:

A. The Board accepts the surrender of Boon's Kansas Registration and it is hereby cancelled.


B. Should Boon make a future application for a Kansas registration, this order shall be considered a revocation of Boon's Kansas Registration.

C. The Summary Order and Request for Hearing are now moot, and no related hearing will be conducted.






