#### FINAL ORDER

The above captioned matter comes before the Board for Formal Hearing this 31 day of March, 1995, at 1:00 P.M. at the Clubhouse Inn Meeting Room, 515 S. Webb, Wichita, Kansas.

The State Board of Pharmacy of the State of Kansas appears by Hoyt Kerr, President and Presiding Officer; Glen Mathis, Vice-President; Dana Creitz, Pharmacist; Monte Baugher, Pharmacist; Charlotte Brock, Pharmacist; and Dr. Margaret Young, Consumer Representative. Also appearing are Tom C. Hitchcock, Executive Secretary, and the attorney for the Board, Dana W. Killinger. Defendant appears personally and with counsel Ms. Lucy Herlocker and Ms. Ann Soderberg.

As a preliminary matter, Ms. Herlocker and Ms. Soderberg asked to approach the Board informally in an effort to settle the matter. Mr. Killinger had no objections.

After offering a possible settlement agreement, the Board

went into Executive Session for quasi-judicial reasons, with Mr. Glen Mathis recusing himself from such session, to consider the offer of settlement by counsels for Defendant.

Upon return to open session, the Board advised all those involved that they wished to hear all the evidence.

Thereupon, Mr. Killinger called as witnesses Ms.

Etta Williams, Dr. Marshall Bales and Ms. Patricia Bradley
and rested plaintiff's case.

Thereupon, Ms. Lucy Herlocker called Dr. Howard Brodsky,

Jerry LeRoy LoVern, and Defendant, Mr. Leslie Craft and

rested Defendant's case.

Thereupon, the Board went into Executive Session for quasi-judicial reasons, with Mr. Glen Mathis recusing himself from such session. Upon returning to open meeting the Board made the following findings of fact and law and made the following ruling.

#### FINDING OF FACT AND LAW

A. Based on the testimony of Dr. Bales and Dr. Brodsky, there is substantial evidence that Defendant is mentally incapacitated to such a degree as to render Defendant unfit to practice the profession of pharmacy as meant by K.S.A. 65-1627(a)(7). This is exhibited by the facts that both Dr. Bales and Dr. Brodsky testified that by not maintaining Defendant's lithium levels he was unfit

to practice pharmacy. By the Doctors' testimony and Defendant's admission, Defendant had the lithium capsules but would not take them in accordance with directions.

Pursuant to K.S.A. 65-1627(a)(7) the State Board of Pharmacy of the State of Kansas has authority to revoke, suspend, place on probation or deny licensure renewal.

IT IS THE ORDER OF THIS BOARD that the Pharmacy License of Leslie D'Air Craft, License No. 1-09786 be revoked and that pursuant to K.S.A. 65-1627h, Defendant pay costs herein.

Pursuant to K.S.A. 77-526 the Defendant is advised of the following administrative remedies:

- (a) Pursuant to K.S.A. 77-529, Defendant has Fifteen
  (15) days from service of the Final Order to file a Petition
  upon the Agency Head for reconsideration.
- (B) Pursuant to K.S.A. 77-528, Defendant may submit a petition on the Agency Head for a stay of the Final Order.
- (C) If no action is taken on the Petition for Reconsideration within Twenty (20) days from filing, the Petition is deemed denied, K.S.A. 77-529(b), and the Defendant has Thirty (30) days to file a Petition for Judicial Review, K.S.A. 77-613.
  - (D) Defendant may make application for reinstatement

of his license to practice pharmacy, One (1) Year from the effective date of this Final Order, K.S.A. 65-1627a.
