FINAL ORDER REVOKING REGISTRATION

NOW ON THIS 2nd day of December, 2010, the above captioned matter comes on for hearing before the Kansas State Board of Pharmacy ("Board"). The Board appears by William C. Rein, Disciplinary Counsel. There are no other appearances.

THEREUPON, being duly advised in the matter, the Board finds that:

1. The Board issued a Petition and Notice of Intent to Revoke the Registration ("Petition") of Jessica Duben, Pharmacy Technician, ("Technician") on September 7, 2010. The Petition was served the same day, by mail, on Technician and counsel for the Board.
2. Technician filed a timely request for hearing.
3. A formal Notice of Administrative Proceeding ("Notice") was served, by mail, on September 17, 2010. The Notice scheduled a hearing before the Board on December 2, 2010 beginning at 9:00 AM. Both Technician and counsel for the Board were ordered to be present for the hearing at the Kansas Board of Pharmacy, 800 SW Jackson, Basement Level, Conference Room A, on that date and time.
4. On or about November 10, 2010, the Board received a letter from Technician withdrawing her request for a hearing. The letter was dated November 10, 2010 and stated, as follows:


"I, Jessica J. Duben, would like to cancel my request for a hearing in Case No: 10-65 which is scheduled for December 2, 2010 at 9:00 AM."

5. As a result of Technician's withdrawal of her request for a hearing, the Board finds that her registration as a pharmacy technician in Kansas should be revoked for the reasons set forth in the Petition on file herein.

WHEREFORE, pursuant to K.S.A. 65-1663(e)(1), K.S.A. 65-1627(a)(3), K.S.A. 65-1627(a)(12), K.S.A. 65-1627a, and K.S.A. 77-501 *et. seq.*, and for the reasons stated in the Petition on file herein, the registration of Jessica Duben as a pharmacy technician in the State of Kansas should be, and the same is hereby revoked.


