SUMMARY ORDER OF REVOCATION

NOW, on this 23rd day of February 2022, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Joshua Fonseca ("Respondent").

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, et seq., and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, et seq., the Board's Executive Secretary enters this Summary Order of Revocation in the above-captioned matter. After reviewing the investigation materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions, and order:

FINDINGS OF FACT

- 1. The Board has previously issued Respondent Pharmacy Technician Registration Number 14-104307 authorizing Respondent to perform the functions of a pharmacy technician in the State of Kansas ("Respondent's Registration").
- 2. On or about January 21, 2022, the Board's Inspector was notified that Stormont-Vail Healthcare Pharmacy ("the Pharmacy") had submitted a DEA Form 106 which indicated the diversion of lorazepam and fentanyl by Respondent.
 - 3. Subsequently, the Board's Inspector conducted an investigation which found that:
 - Respondent had been employed as a pharmacy technician at the Pharmacy.

- Respondent and the Pharmacy's Technician Supervisor had exchanged texts messages
 of a graphic nature, along with messages and photos indicating theft/diversion of
 lorazepam and sildenafil from the Pharmacy.
- Respondent subsequently admitted to the theft/diversion from the Pharmacy of all items contained in the messages: lidocaine, lorazepam, sildenafil, and fentanyl.
- Respondent stated he was not currently using the diverted drugs.
- Respondent was terminated from the Pharmacy on January 3, 2022, for the diversion.

CONCLUSIONS OF LAW

- 1. Pursuant to K.S.A. 65-1663, the Board may revoke a registration as a pharmacy technician on any ground which would authorize the Board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.
- 2. Pursuant to K.S.A. 65-1627(a)(3), the Board may revoke the licensee of any pharmacist who is found by the Board to be guilty of unprofessional conduct.
- 3. Pursuant to K.S.A. 65-1626(vvv), unprofessional conduct includes the unlawful possession of drugs or diversion of drugs to others, and conduct likely to harm the public.
- 4. Respondent's conduct of having stolen from his employer, as well as his disregard for the potential harmful effects of his actions on the public, are bases to revoke Respondent's Registration pursuant to K.S.A. 65-1627(a)(3).
- 5. Of some concern may be Respondent's conduct with/towards his supervisor which was questionable in nature in view of their professional association.

ORDER

Based upon the foregoing findings of fact and conclusions of law, Respondent's Registration is hereby REVOKED.

NOTICES

The Respondent is hereby notified as follows:

1. The Respondent may request a hearing pursuant to the Kansas Administrative

Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson,

Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.

2. If a hearing is not requested as described above, the Order shall become a final

order of the Board, effective upon the expiration of the time to request a hearing.

3. Within fifteen (15) days after entry of a final agency order, either party may file a

petition for reconsideration pursuant to K.S.A. 77-529.

4. Within the time limits established in K.S.A. 77-613, either party may seek judicial

review of a final agency order, pursuant to said statute. The agency officer designated to receive
