STIPULATION OF FINDING OF FACT AND ORDER

This matter comes before the State Board of Pharmacy for the State of Kansas, this 26th day of January, 1992.

The State Board of Pharmacy appears by Hoyt Kerr, President and Presiding Officer, Dana Creitz, Vice-President; Kathleen Mahanna, Pharmacist; Barbara Renick, Pharmacist; Charlotte Brock, Pharmacist; and Margaret Young, Consumer Representative. Also appearing are Tom C. Hitchcock, Executive Secretary, and the attorney for the Board, Dana W. Killinger. Ronald L. Freed appears personally.

Ronald L. Freed states that he has been advised of his procedural rights under the Pharmacy Practice Act and Administrative Procedure Act, wherein Counsel for the Board advised Ronald L. Freed of his rights to a formal hearing wherein he had a right to be represented by counsel, call witnesses on his behalf, cross examine the Board's witnesses and other procedural rights. Counsel further advised Ronald L. Freed of the statutory sections of the

law which were allegedly violated and the statute giving the Board jurisdiction in the matter. Whereupon Ronald L. Freed waived his right to formal hearing.

Ronald L. Freed further states that no issue of fact exists and wishes to stipulate to the following findings of fact and accepts the order of the State Board of Pharmacy, to-wit:

1. That Ronald L. Freed, is a licensed pharmacist in the State of Kansas, having License No. 8243.

2. That Ronald L. Freed is the Pharmacist in Charge of Freed's Pharmacy, Registration No. 6586 at 6394 College Blvd., Overland Park, Kansas 66211.

3. That upon the inspection of Ronald L. Freed's Pharmacy on December 13, 1990, the Board Inspector found 52 prescriptions for controlled substances having no physician's address, all in violation of 21 C.F.R. 1306.05 and K.S.A. 65-1627(a) & (5).

4. That upon the inspection of Ronald L. Freed's pharmacy on December 13, 1990, the Board Inspector found four prescriptions for controlled substances having no patient's address, all in violation of 21 C.F.R. 1306.05 and K.S.A. 65-1627(a)(5).

5. That Ronald L. Freed has failed to comply with

the statutory and regulatory requirements imposed by the State upon pharmacists licensed by the State.

6. That the State Board of Pharmacy of the State of Kansas pursuant to K.S.A. 65-1627(a)(5) has jurisdiction and power to revoke, suspend or place on probation said Ronald L. Freed.

IT IS THEREFORE ORDERED that Ronald L. Freed, License No. 8243, take the law exam at the Pharmacy Board's Office in Topeka, Kansas, within thirty (30) days of the date of signing by the Board President, Hoyt Kerr. Ronald L. Freed must pass said law exam with a score of 75 and should Ronald L. Freed fail to pass said law exam with a score of 75 the Board's attorney is directed to file a Formal Petition.


