SUMMARY ORDER OF DENIAL

NOW, on this 11th day of February 2022, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Christian Graham ("Applicant"), for application for a Kansas pharmacy technician registration.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, et seq., and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, et seq., the Board's Executive Secretary enters this Summary Order of Denial in the above-captioned matter. After reviewing the application materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions, and order:

FINDINGS OF FACT

- 1. On September 27, 2021, the Board received Applicant's application for registration as a pharmacy technician in the State of Kansas ("Applicant's Application").
- 2. As part of the application, Applicant answered "YES" to the questions: Have you ever been charged with or convicted of (includes plea of guilty or no contest) a criminal offense or is there any criminal charge now pending against you (other than minor traffic violations) in any state or federal court whether or not a sentence was imposed, suspended, or diverted? This includes misdemeanors and Have you ever been charged with or convicted of (includes plea of guilty or no contest) a violation of any federal or state drug law(s) or rule(s) whether or not a

sentence was imposed, suspended, or diverted? The application directs that if the applicant answers "YES", they must attach a Form S-150: Personal History ("S-150").

- 3. Applicant's S-150 statement briefly noted a 2016 drug paraphernalia misdemeanor, for which Applicant went to court, pled guilty, and was sentenced to attend a class. Applicant had included no court documentation to support the charge or the outcome listed in his S-150 statement.
- 4. On October 1, 2021, the Board sent a letter to Applicant's address of record requesting he provide certified copies of the court pleadings from the case. Applicant did not respond to the Board's request.
- 5. On November 2, 2021, the Board sent a second letter to Applicant's address of record, again requesting certified copies of the court pleadings. Applicant did not respond to the Board's second request.
- 6. On December 6, 2021, the Board sent a final letter to Applicant's address of record, requesting the certified court documents one final time.
- 7. To date, the Board has received from Applicant neither the court documents nor any correspondence.

CONCLUSIONS OF LAW

- 1. Pursuant to K.S.A. 65-1663(f)(1), the Board may deny an application for issuance of any registration as a pharmacy technician on any ground which would authorize the Board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.
- 2. Pursuant to K.S.A. 65-1627(a)(15), the Board may deny an application of any license of any pharmacist upon a finding that the licensee has failed to furnish to the Board, its investigators, or its representatives any information legally requested by the Board.

3. Applicant's failure to supply the Board with the requested court documentation, necessary to complete his Application, is a basis to deny Applicant's Application pursuant to K.S.A. 65-1627(a)(15).

ORDER

Based upon the foregoing findings of fact and conclusions of law, Applicant's Application is hereby DENIED.

NOTICES

The Applicant is hereby notified as follows:

- 1. Applicant may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.
- 2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.
- 3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.
- 4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is:
