SUMMARY ORDER

NOW, on this 2nd day of July 2019, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Anna Kurtz, ("Applicant"), for application for registration as a Kansas pharmacy technician.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board's Executive Secretary enters this Summary Order in the above-captioned matter. After reviewing the application materials and being otherwise duly advised in the premises, makes the following findings, conclusions and order.

FINDINGS OF FACT

- 1. On March 15, 2019, the Board received Applicant's application for registration as a pharmacy technician in the State of Kansas ("Applicant's Application").
- 2. Applicant answered "Yes" to the following questions on her application: (1) Have you been charged with or convicted of (includes plea of guilty or no contest) a criminal offense or is there any criminal charge now pending against you (other than minor traffic violations) in any state or federal court whether or not a sentence was imposed, suspended, or diverted? This includes misdemeanors; and (2) Are you now or have you in the last five years been treated for a drug or alcohol addiction or participated in any substance abuse rehabilitation program?

Applicant disclosed a July 2006 charge for driving under the influence of alcohol to which she pleaded guilty and completed 48 hours of jail time, 12 months of probation, and other court-mandated requirements. Applicant also disclosed that she admitted herself to a substance use treatment facility in 2018 and had been sober since that time. Applicant provided copies of relevant court documents and additional treatment and training completion certificates.

- 3. The Board received additional information regarding a December 2003 charge against Applicant for driving under the influence of alcohol.
- 4. In June 2019, the Board's Individual License Evaluator conducted a phone interview with Applicant. Applicant explained her substance use and criminal offense history, including her continued treatment and sobriety since April 2018, and an understanding of the seriousness of her past DUI offenses.

CONCLUSIONS OF LAW

- 1. That pursuant to K.S.A. 65-1663, the Board may limit, suspend, or revoke a registration or deny an application for issuance or renewal of any registration as a pharmacy technician on any ground which would authorize the board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.
- 2. Pursuant to K.S.A. 65-1627(a)(3), the Board may place in a probationary status the license of any pharmacist who has been found guilty of unprofessional conduct.
- 3. Pursuant to K.S.A. 65-1626(ttt), unprofessional conduct means conduct likely to deceive or harm the public.
- 4. Though it has been more than ten years since Applicant's last criminal infraction or involvement and Applicant has maintained sobriety for over a year, Applicant's past DUI criminal offenses and history of substance use create the potential for risk in a pharmacy

environment. Given the importance of ensuring public safety and monitoring Applicant in an environment with controlled substances and patient healthcare, Applicant's criminal and substance use history are considered unprofessional conduct and a basis to place Applicant's registration in a probationary status pursuant to K.S.A. 65-1627(a)(3).

ORDER

Based upon the foregoing findings of fact and conclusions of law, Applicant's Application for issuance of pharmacy technician registration is hereby GRANTED subject to a 2-year probationary status. The terms of Applicant's probation are as follows:

- Applicant must notify the Board of any change in employment within 10 days of the change and obtain Board approval for the change;
- Applicant must inform employers of the probationary status of her pharmacy technician registration;
- Applicant must obtain the signature of her pharmacist-in-charge (PIC) documenting knowledge of probationary status to the Board; and
- Applicant must comply with all rules and regulations of the Pharmacy Practice

 Act.

NOTICES

Applicant is hereby notified as follows:

- 1. Applicant may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.
- 2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.

- 3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.
- 4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is
