SUMMARY ORDER REVOKING LICENSE REGISTRATION

NOW on this 31 day of March, 2016, comes before the Kansas Board of Pharmacy (the “Board”), through its Investigation Member, the matter of Laquita Michele Lewis, Pharmacy Technician (“Respondent”).

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board’s Investigation Member enters this Summary Order of Revocation in the above-captioned matter. After reviewing the investigation materials and being otherwise duly advised in the premises, makes the following findings, conclusions and order:

FINDINGS OF FACT

For purposes of this order, the Board’s Investigative Member makes the following findings of fact:

1. The Board has issued Respondent Pharmacy Technician Registration Number 14-11585 authorizing her to perform the functions of a pharmacy technician in the State of Kansas (“Respondent’s Registration”).
2. On October 23, 2015, Respondent submitted a check in the amount of \$20 for her license renewal.

3. Thereafter, the Board received notification that Respondent's check was returned due to insufficient funds.

4. On February 2, 2016, the Board requested payment on or before February 17, 2016.

5. To date, the Board has not received a renewal payment from Respondent.

CONCLUSIONS OF LAW

6. That pursuant to K.S.A. 65-1663(d), each applicant for renewal of a pharmacy technician license shall be accompanied by a renewal fee fixed by the Board.

7. Upon renewing her license, Respondent attached a check that was returned for insufficient funds.

8. To date, Respondent has failed to furnish the Board with any information regarding the bad check. Therefore, Respondent has failed to provide the mandatory renewal fee to the Board and has not complied with the requirements for renewal of her technician registration.

ORDER

Based upon the foregoing findings of fact and conclusions of law, Respondent's Registration is hereby REVOKED. Further, the Board orders that Respondent should be and hereby is assessed a \$30 service charge for the returned check, which shall be paid to the Board by Wednesday, May 4th, 2016.

NOTICES

The Respondent is hereby notified as follows:

9. The Respondent may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy,

10. If a hearing is not requested as described above, the Order revoking the Respondent's Registration, as a pharmacy technician shall become a final order of the Board, effective upon the expiration of the time to request a hearing.


11. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

12. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is:


