SUMMARY ORDER OF REVOCATION

NOW, on this 28th day of January 2021, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Megan Major ("Respondent").

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board's Executive Secretary enters this Summary Order of Revocation in the abovecaptioned matter. After reviewing the investigation materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

FINDINGS OF FACT

1. The Board has issued Respondent Pharmacy Technician Registration Number 24-111851 authorizing Respondent to perform the functions of a pharmacy technician in the State of Kansas ("Respondent's Registration").

2. At all times relevant hereto, Respondent was employed as a pharmacy technician at Walgreens Pharmacy #9985 in Leawood, Kansas ("the Pharmacy").

3. On September 17, 2020, the Board's investigator received a notification of a theft/loss of controlled substances from the Pharmacy which indicated that a police report had been filed and a DEA report in process as a result of an employee pilferage committed by Respondent. Subsequently, the Board's inspector conducted an investigation.

- 4. The investigation documents revealed the following:
 - On September 14, 2020, the Pharmacy's store manager had witnessed an Adderall tablet drop from Respondent's pocket.
 - Pharmacy video tape confirmed that Respondent had on that same day filled an
 Adderall prescription from which she pocketed the tablets.
 - On September 17, 2020, Respondent was interviewed by and signed a statement before the Pharmacy's asset protection manager, in which she admitted to having taken Adderall, Xanax, Vyvanse, Valium, and Ritalin from the Pharmacy, and claimed her declining mental health status as her motivation for the theft.
 - Respondent's employment with the Pharmacy was therefore terminated, and charges immediately filed with the Leawood Police Department.

CONCLUSIONS OF LAW

1. That pursuant to K.S.A. 65-1663 the Board may limit, suspend, or revoke a registration or deny an application for issuance or renewal of any registration as a pharmacy technician on any ground which would authorize the board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.

2. That the Board may take action against the license of a pharmacist for unprofessional conduct or professional incompetency as set forth in K.S.A. 65-1627(a)(3).

3. That K.S.A. 65-1626(uuu) defines unprofessional conduct to include the unlawful possession of drugs and/or conduct likely to deceive, defraud, or harm the public.

4. Respondent's conduct in stealing drugs from her employer and Respondent's disregard for the potential harmful effects of her action to the public are violations of K.S.A. 65-1627(a)(3) and are bases to revoke Respondent's Registration.

<u>ORDER</u>

Based upon the foregoing findings of fact and conclusions of law, Respondent's Registration is hereby REVOKED.

NOTICES

The Respondent is hereby notified as follows:

1. The Respondent may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.

2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.

3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is:
