FINAL ORDER

Statement of Case

This matter comes on for hearing before the Kansas Board of Pharmacy (Board) upon the application of Jason Marrs for registration as a pharmacy technician in the State of Kansas.

The hearing in this matter was held on March 8, 2018. Appearing for the Board were: John Worden, PharmD, President; Michael Lonergan, R.Ph., Vice President; and members, Jonathan Brunswig, PharmD; Robert Haneke, PharmD; Cheri Pugh, Public Member, Chad Ullom, R.Ph., and Bill Walden, R.Ph.

Randall J. Forbes appeared as the Board's disciplinary counsel.

Jason Marrs appeared pro se.

Findings of Fact

- 1. On July 21, 2017, the Board received Mr. Marrs' application for registration as a pharmacy technician in the State of Kansas (application).
- 2. On his application, Mr. Marrs answered "No" to the question: "Have you been convicted of (includes pleas of guilty or no contest) a criminal offense or is there any criminal charge pending against you (other than minor traffic violations) in any state or federal court whether or not a sentence was imposed, suspended, or diverted?"

- 3. On August 15, 2018, the Board notified Mr. Marrs that the background report from the Kansas Bureau of Investigation indicated that he had a 2008 DWI, 2008 criminal use of weapon, and 2012 felony distribution of controlled substance charges which he had failed to disclose to the Board.
- 4. The Board requested that Mr. Marrs compete a S-150 Form, as well as certified copies of the court pleadings from the case. In the event no criminal records were available for a case, Mr. Marrs was directed to provide a letter from the clerk of the court stating that there were no records available.
- 5. The Board received the S-150 Form explaining that he had answered no as to the DWI because he was not convicted. He stated that he contacted the "State Office" to get the paperwork and was told because the DWI happened nine years ago, the could not find any records on it.
- 6. As to the 2008 criminal use of a weapon, Mr. Marrs stated that he had purchased a weapon legally and was in his backyard target practicing and someone called the police. He stated that he entered a plea to discharging a firearm in city limits and was given two weeks of house arrest. Mr. Marrs claimed that charge was not supposed to be on his record, so he answered no.
- 7. As to the 2012 felony distribution of a controlled substance charge, Mr.

 Marrs provided a Notice of Inability to Process (Notice) from the Circuit

 Court of Jackson County, Missouri, which he claimed showed that he was

never charged with a felony. The Notice, however, indicated that the Department of Criminal Records had performed a cursory database search for the records requested by Mr. Marrs and confirmed that the search produced no results but neither confirmed or denied that a record may indeed exist.

- 8. Mr. Marrs also stated that he has a pharmacy license in Missouri and is working security at a pharmacy in Missouri. He currently resides in Missouri.
- 9. On December 11, 2017, the matter was reviewed by the Investigative Member of the Board and it was determined that the matter would be set for hearing before the full Board.
- 10. Mr. Marrs appeared and testified on his own behalf.

Applicable Law and Discussion

- 1. Pursuant to K.S.A. 65-1663, the Board may limit, suspend, or revoke a registration or deny an application for issuance or renewal of any registration as a pharmacy technician on any ground which would authorize the Board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.
- 2. K.S.A. 65-1627(a)(2) provides that the Board may deny an application for registration as a pharmacy technician if the applicant "has been convicted of a misdemeanor involving moral turpitude or gross immorality or any

- felony and the licensee fails to show that the licensee has been sufficiently rehabilitated to warrant the public trust."
- 3. During the hearing, Mr. Marrs' testimony as to the DWI and the firearm were consistent with what he had stated on the S-150 form. As to the 2012 felony distribution of a controlled substance charge, he testified that he was "at the wrong place, at the wrong time."
- 4. Based on the evidence provided, the Board finds that denial of Mr. Marrs' application for registration as a pharmacy technician in the State of Kansas is warranted.
- 5. Mr. Marrs was not forthcoming on his application with regard to his criminal background.
- 6. In addition, Mr. Marrs has failed to provide any documentary evidence as to the DWI and the firearm offenses. While he did provide the Notice with regard to the felony distribution charge, the Notice only indicated that upon a "cursory" search of the database, there were no results. The Board is unwilling to rely solely on Mr. Marrs' testimony as to each of these matters.
- 7. In addition, Mr. Marrs failed to provide any evidence as to his character such as letters of recommendation from employers.

<u>Order</u>

On the unanimous vote of the Board, Mr. Marrs' application for registration as a Kansas pharmacy technician is denied.

- 2. Within fifteen (15) days after service of the Final Agency Order, any party may file a Petition for Reconsideration pursuant to K.S.A. 77-529.
