#### SUMMARY ORDER

NOW, on this 11th day of January 2021, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Jessica McMillan, ("Applicant"), for her renewal application for registration as a Kansas pharmacy technician.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board's Executive Secretary enters this Summary Order in the above-captioned matter. After reviewing the application materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order.

#### FINDINGS OF FACT

1. On October 12, 2020, the Board received Applicant's renewal application for registration as a pharmacy technician in the State of Kansas ("Applicant's Application").

2. Applicant answered "Yes" to the following question on his application: "Have you been charged with or convicted of (includes plea of guilty or no contest) a criminal offense or is there any criminal charge now pending against you (other than minor traffic violations) in any state or federal court whether or not a sentence was imposed, suspended, or diverted? This includes misdemeanors." The application directs that if an applicant answers "yes", they must include a Personal History Form S-150 ("S-150").

3. Applicant's S-150 included a forthcoming statement noting a July 2020 theft charge currently under diversion, but included no support court documentation.

4. On October 13, 2020, the Board sent a letter to Applicant's email address of record requesting certified copies of the court pleadings from the case.

5. On October 22, 2020, the Board received the requested documentation. Applicant's personal statement and court documents noted that Applicant's 12-month diversion agreement for the theft charge was approved on October 8, 2020.

6. Applicant's personal statement demonstrated personal responsibility for her wrongdoing, her wish to make restitution, and her commitment not to make the same choice again moving forward. Applicant is currently under court diversion until October 2021 for the theft.

### CONCLUSIONS OF LAW

1. That pursuant to K.S.A. 65-1663, the Board may limit, suspend, or revoke a registration or deny an application for issuance or renewal of any registration as a pharmacy technician on any ground which would authorize the board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.

2. Pursuant to K.S.A. 65-1627(a)(3), the Board may place in a probationary status the license of any pharmacist who has been found guilty of unprofessional conduct.

3. Pursuant to K.S.A. 65-1626(uuu), unprofessional conduct means conduct likely to deceive, defraud, or harm the public.

4. Applicant's diverted conviction is a basis to place Applicant's registration in a probationary status pursuant to K.S.A. 65-1627(a)(2), as she is still under her diversion

agreement and therefore, unable to show that she has been sufficiently rehabilitated to warrant the public trust at this time.

5. Applicant's theft by deception is unprofessional conduct and poses a risk to pharmacy patients due to the environment and access to patient financial information and drugs. Therefore, the Board has reason to grant Applicant's registration on a probationary status pursuant to K.S.A. 65-1627(a)(3) which will require supervision and oversight.

# <u>ORDER</u>

Based upon the foregoing findings of fact and conclusions of law, Applicant's Application for renewal of pharmacy technician registration is hereby GRANTED subject to a 2-year probationary status. The terms of Applicant's probation are as follows:

- Applicant must continue compliance with the terms of her court diversion;
- Applicant must notify the Board of any change in her court diversion status within 10 days of the change;
- Applicant must notify the Board of any arrest or criminal charge within 10 days of the date of the arrest or charge;
- Applicant must notify the Board of any change in employment within 10 days of the change and obtain Board approval for the change;
- Applicant must inform employers of the probationary status of her pharmacy technician registration;
- Applicant must obtain the signature of her pharmacist-in-charge (PIC) documenting knowledge of his probationary status to the Board; and
- Applicant must comply with all rules and regulations of the Pharmacy Practice Act.

### NOTICES

Applicant is hereby notified as follows:

 Applicant may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.

2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.

3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is
