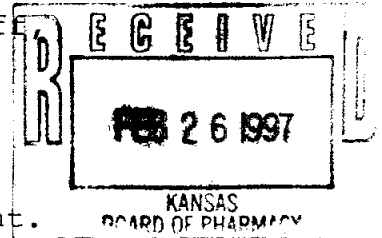

ORDER TO SHOW CAUSE

NOW, on this 26<sup>th</sup> day of February, 1997,

IT IS ORDERED BY THE STATE BOARD OF PHARMACY FOR THE STATE OF KANSAS, that Janet Oates Ralstin show cause why her license should not be suspended or revoked. A Formal Administrative hearing will held on the 4th day of April, 1997, at 10:00 A.M. at Room 6052, Malott Hall, University of Kansas, Lawrence, Kansas. The purpose of said hearing is to receive evidence regarding the issue of revocation of License No. 1-10022. The Licensee will be given a full opportunity to confront witnesses against her and present evidence on her behalf. While it is not a Board requirement, the Licensee may be represented by counsel at such hearing, request a prehearing conference prior to the formal hearing, and call witnesses on her behalf.

The State Board of Pharmacy for the State of Kansas

has issued this Order to Show Cause under the provisions of K.S.A. 65-4118(3) and 65-4119(a).


The basis of this Order is as follows:


1. That in October and November of 1996, said Defendant Janet Oates Ralstin did remove Morphine sulfate injection vials and diverted same to her own use without a valid prescription, a violation of K.S.A. 65-4160 and K.A.R. 68-20-19(a).

2. That no record of such diversion was made by Defendant, Janet Oates Ralstin, and such is a violation of K.S.A. 65-4121 and K.A.R. 68-20-16.

The Presiding Officer at said hearing will be Karla Kneebone, President, R.R. 2, Neodesha, Kansas 66757, Phone: Work: (316)325-2611; Home: (316)325-2196. Failure to appear or take part in this hearing or any other stage of this matter may result in your being held in default according to the Administrative Procedure Act and the Board may take any action it deems appropriate according to law.
