If you disagree with the findings of fact, you have the right to request a hearing. Instructions for filing a written request are included under the "Notices" section of the order. Hearings are held before the full Board during their regularly scheduled quarterly meetings.

According to KSA 65-1627h, the Board is required to recoup the costs of administrative hearings when the decision is adverse to the licensee. These costs may include charges for services rendered by the Board's disciplinary counsel, an administrative law judge, and, if applicable, a court reporter.

SUMMARY ORDER

NOW, on this 24th day of February 2022, comes before the Kansas Board of Pharmacy (the “Board”), through its Executive Secretary, the matter of Jason Revel, (“Applicant”), for application for reinstatement of his Kansas pharmacist license.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board’s Executive Secretary enters this Summary Order in the above-captioned matter. After reviewing the application materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order.

FINDINGS OF FACT

1. Applicant was previously issued a Kansas pharmacist license, number 1-13915, by the Board on July 1, 2005. Applicant timely renewed his license every two years but allowed it to expire for non-renewal on June 30, 2021.
2. On November 1, 2021, the Board received Applicant’s application for reinstatement of his Kansas pharmacist license (“Applicant’s Application”).
3. Applicant answered “Yes” to the following question on his application: “Have you ever been the subject of any disciplinary action taken against a professional or occupational

license or registration.” The application directs that if the applicant answers yes, the applicant must attach a Form S-150: Personal History (“Form S-150”).

4. In conjunction with Applicant’s Application, he provided a Form S-150 and supporting documentation of discipline against Applicant’s Oklahoma pharmacist license by the Oklahoma Board of Pharmacy on or around January 13, 2021.

5. Applicant had not previously reported the January 2021 Oklahoma discipline to the Board.

CONCLUSIONS OF LAW

1. Pursuant to K.S.A. 65-1658, the Board may assess a civil fine not to exceed \$5,000, after notice and an opportunity to be heard, to any registrant for violation of the pharmacy act of the state of Kansas or any other rules or regulations of the state board of pharmacy.

2. Pursuant to K.A.R. 68-7-25, each pharmacist shall notify the Board in writing within 30 days of any disciplinary action taken by another jurisdiction against any pharmacist license held by the pharmacist.

3. Applicant first notified the Board of the January 2021 Oklahoma Board of Pharmacy disciplinary action in conjunction with Applicant’s Application received on November 1, 2021.

4. Applicant was a license pharmacist in Kansas at the time of the January 2021 Oklahoma Board of Pharmacy disciplinary action.

5. Applicant failed to notify the Board of his Oklahoma Board of Pharmacy disciplinary action within 30 days which is a violation of K.A.R. 68-7-25.

ORDER

Based upon the foregoing findings of fact and conclusions of law, Applicant's Application is hereby GRANTED but Applicant is ordered to pay a fine to the Board in the amount of \$500. Applicant has 30 days from the date of this order to pay the fine and the pharmacist license shall be issued upon receipt.

NOTICES

Applicant is hereby notified as follows:


1. Applicant may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.
2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.
3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.
4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is
