## **SUMMARY ORDER**

NOW on this A day of December, 2013, comes before the Kansas State Board of Pharmacy through its investigative member (hereinafter referred to as the "Board") on the permit of Ryan Revoir (hereinafter referred to as the "Respondent") to function as a pharmacy technician in Kansas.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, et seq., and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, et seq., the Board's Investigative Member enters this Summary Order in the above-captioned matter. After reviewing the investigative file and being otherwise duly advised in the premises, makes the following findings, conclusions and order:

## **FINDINGS OF FACT**

- 1. Respondent holds a Kansas pharmacy technician registration and permit, and is subject to the jurisdiction of the Board.
- 2. At all times relevant herein Respondent was employed as a pharmacy technician at Auburn Pharmacy in Overland Park, Kansas.
- 3. On or around November 18, 2013 the respondent was terminated after the pharmacy discovered discrepancies in their inventory for Morphine ER 15 mg, Hydrocodone/APAP 10/325 mg, and Tramadol 50 mg.

4. The Respondent admitted that he diverted Tramadol and adjusted the inventory by going into the computer system under another technician's open log-in.

#### **CONCLUSIONS OF LAW**

- 1. Pursuant to K.S.A. 65-1663 a pharmacy technician registration may be limited, suspended or revoked on any ground, which would authorize the Board to take action against the license of a pharmacist under K.S.A. 65-1627.
- 2. Pursuant to K.S.A. 65-1627 (a) (4) the Board may take action against a pharmacist if the licensee is addicted to liquor or has a drug habit to such a degree as to render the licensee unfit to practice pharmacy.
- 3. Pursuant to K.S.A. 65-1627 (a) (5) the Board may take action against a pharmacist or pharmacy technician for any violation of the Uniform Controlled Substance Act.
- 4. Pursuant to 21 § 1301.92 it is the position of the Drug Enforcement Agency that employees who possess, sell, use or divert controlled substances will subject themselves not only to State or Federal prosecution for any illicit activity, but shall also immediately become the subject of independent action regarding their continued employment.

#### ORDER

IT IS THEREFORE ORDERED that Respondent Ryan Revoir's pharmacy technician registration and permit be hereby revoked.

## IT IS SO ORDERED.

## **NOTICES**

The Respondent is hereby notified as follows:

- 1. The Respondent may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas State Board of Pharmacy, 800 SW Jackson Street, Suite 1414, Topeka, Kansas 66612-1244 within (15) fifteen days after service of this Order.
- 2. If a hearing is not requested as described above, the Order revoking the Respondent's registration and permit shall become a final order of the Board, effective upon the expiration of the time to request a hearing.
- 3. Within (15) fifteen days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.
- 4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute.
