MODIFICATION OF CONSENT ORDER

The application of Gregory Stites, R.Ph. ("Licensee") to terminate the probationary status of Licensee's pharmacist license, established by the Consent Order entered in this case on November 30, 2011 (the "Consent Order"), was heard before the Kansas Board of Pharmacy (the "Board") on June 6, 2013. Mr. Stites presented evidence in support of his application and requested to pay a fine in lieu of serving the remainder of his probation. After hearing the evidence presented, the Board determined:

- 1. That Licensee presented sufficient evidence for the Board to conclude that the justifications for a four (4) year period of probation no longer applied or that the probation period should be terminated.
- 2. Licensee shall be fined \$500 for violation of K.A.R. 68-7-11 to be submitted to the Board within 30 days of receipts of this Order.

IT IS THEREFORE ORDERED that the Licensee's application to remove the probationary status from his pharmacist license shall be approved, Licensee shall pay aforementioned fine, and that the provisions of the Consent Order shall be modified by this Modification of Consent Order.
