# **SUMMARY ORDER**

NOW on this <u>12</u> day of June, 2018 comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Allied Medical Equipment (16-00199) ("Respondent").

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, et seq., and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, et seq., the Board's Executive Secretary enters this Summary Order in the above-captioned matter. After reviewing the investigation materials and being otherwise duly advised in the premises, makes the following findings, conclusions and order:

### FINDINGS OF FACT

- 1. The Board has previously issued Respondent Registration No. 16-00199 which entitles Respondent to provide Durable Medical Equipment (DME) in the State of Kansas ("Respondent's Registration").
- 2. On March 1, 2018, the address of Respondent's facility was changed from 15301 W 87<sup>th</sup> St, Parkway Suite B30, Lenexa, KS 66219 to 10559 Rene St, Lenexa, KS 66215.
- 3. On March 13, 2018, the Board received an email from Respondent notifying of a change of address for the facility. The email did not include a Form BA-16 Address Change Application.

- 4. On March 15, 2018, having not received a Form BA-16 from Respondent, the Board cancelled the Respondent's Registration. The Board sent Respondent an email notifying Respondent of the cancellation and what steps Respondent needed to take to change the address.
- 5. On March 19, 2018, the Board received an incomplete address change application with payment indicating that the change in address was effective March 1, 2018. The Board sent Respondent an email requesting documents to complete the Application.
- 6. On March 21, 2018, a Board inspector conducted the pre-opening inspection and concluded Respondent was operating during the unlicensed period of March 1, 2018 through March 21, 2018.
- 7. On March 22, 2018, Respondent submitted the required documents to complete the Application and the Board issued the Registration with the updated address.

# **CONCLUSIONS OF LAW**

- 8. Pursuant to K.S.A. 65-1658, the Board may assess a civil fine not to exceed \$5,000, after notice and an opportunity to be heard, to any registrant for violation of the pharmacy act of the state of Kansas or any other rules or regulations of the state board of pharmacy.
- 9. Pursuant to K.S.A. 16-1643(m), it shall be unlawful for any person to sell or lease durable medical equipment without first obtaining a registration from the Board, in accordance with rules and regulations adopted by the Board.
- 10. Respondent's failure to notify the Board of its change in address and obtain a new DME registration until March 22, 2018 twenty-one days after the address change occurred

while operating at the new address – means Respondent was operating as a DME without a valid permit, in violation of K.S.A. 1643(m).

#### <u>ORDER</u>

The Board finds and concludes that Respondent's conduct, as described above, violates the Act and such conduct warrants the imposition of a fine pursuant to K.S.A. 65-1658, in the amount of \$500.00. Respondent has 30 days from the date of this order to pay the full \$500.00.

### NOTICES

The Respondent is hereby notified as follows:

- 1. The Respondent may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.
- 2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.
- 3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.
- 4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is:
