SUMMARY ORDER OF DENIAL

NOW, on this 25rd day of October 2019, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Direct Dose Rx ("Respondent").

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board enters this Summary Order of Denial in the above-captioned matter. After reviewing the renewal materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions, and order:

FINDINGS OF FACT

1. On or about July 5, 2019, the Board received Respondent's Non-Resident Pharmacy Registration Application.
2. On July 8, 2019, the Board sent Respondent a request for authorized resident agent ("Agent") information, which was missing from Respondent's application.
3. On August 15, 2019, the Board sent Respondent a second request for the Agent information that was missing from Respondent's application.
4. On September 16, 2019, the Board sent Respondent a third and final request for the Agent information that was missing from Respondent's application.
5. To date, the Board has not received any Agent information from Respondent.

CONCLUSIONS OF LAW

1. Pursuant to K.S.A. 65-1657(a), applications for a nonresident pharmacy registration shall be made on a form furnished by the Board, and registration shall be granted upon compliance with the provisions of K.S.A. 65-1657 and rules and regulations adopted pursuant to such, and upon payment of the registration fee.

2. Pursuant to K.S.A. 65-1657(b)(1), as condition for the granting of a registration for a nonresident pharmacy, the nonresident pharmacy shall supply upon request all information needed by the Board to carry out the Board's responsibilities under K.S.A. 65-1657 and rules and regulations adopted pursuant to such.

3. Respondent's failure to provide the Board with the required application information is a basis not to grant Respondent's application, pursuant to K.S.A. 65-1657(b)(1).

4. Pursuant to K.A.R. 68-7-12a(i), to be registered in Kansas by the Board, each nonresident pharmacy shall meet the requirement of designating a resident agent in Kansas.

5. Respondent's failure to provide the Board with the required Agent information indicates that Respondent has not met the requirement set forth in K.A.R. 68-7-12a(i), and as such is a basis not to grant Respondent's registration.

ORDER

Based upon the foregoing findings of fact and conclusions of law, Respondent's Nonresident Pharmacy Registration Application is hereby DENIED.

NOTICES

Respondent is hereby notified as follows:

1. Respondent may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414,

Topeka, KS 66612-1231, within 15 days after service of this Order. If the outcome of the hearing is adverse to Respondent, costs of the proceedings shall be charged to Respondent.

2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.

3. Within 15 days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.


4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to K.S.A. 77-613. The agency officer designated to receive service of a petition for judicial review is:
