SUMMARY ORDER

NOW, on this 16 day of September 2019, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Director, the matter of Innovel Solutions #8273 ("Respondent").

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, et seq., and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, et seq., the Board's Executive Secretary enters this Summary Order in the above-captioned matter. After reviewing the investigation materials and being otherwise duly advised in the premises, makes the following findings, conclusions and order:

FINDINGS OF FACT

- 1. The Board has previously issued Respondent Registration No. 6-00436 which entitles Respondent to operate as a nonprescription drug distribution facility (NPD) in the State of Kansas ("Respondent's Registration").
- 2. On February 11, 2019, ownership of Respondent's facility was changed from Kmart Corporation to Transform Innovel Solutions, LLC. In addition on this same date, the name of Respondent's facility was changed from Kmart #8273 to Innovel Solutions #8273.

- 3. On June 24, 2019, the Board received Form BA-06 NPD Distributor Registration Application from Respondent, notifying the Board of the February 11th changes in name and ownership.
- 4. On July 9, 2019, the Board approved Respondent's Nonprescription Drug Distributor Application, effective immediately.
- 5. With the July 9, 2019 approval, Respondent's previous registration number 6-00436 was cancelled, effective February 11, 2019, and Respondent was issued new NPD registration number 6-109973, under new name and ownership.

CONCLUSIONS OF LAW

- 6. Pursuant to K.S.A. 65-1658, the Board may assess a civil fine not to exceed \$5,000, after notice and an opportunity to be heard, to any registrant for violation of the pharmacy act of the state of Kansas or any other rules or regulations of the state board of pharmacy.
- 7. Pursuant to K.A.R. 68-2-9, each registrant shall notify the executive secretary of the board in writing of any change in majority ownership of the operation for which the registration was issued within five days after the date the change in ownership becomes effective.
- 8. Respondent had five days to notify the Board of the change in ownership, or until February 16, 2019.
- 9. Respondent failed to notify the Board of the ownership change until June 24, 2019, which was 128 days beyond the five-day window for notification to the Board.
- 10. Respondent violated K.A.R. 68-2-9 when failing to notify the Board of a change in ownership within five days.

ORDER

Based upon the foregoing findings of fact and conclusions of law, Respondent is ordered to pay a fine in the amount of \$500.00 to the Board. Respondent has 30 days from the date of this order to pay the full \$500.00.

NOTICES

The Respondent is hereby notified as follows:

- 1. The Respondent may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.
- 2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.
- 3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.
- 4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is:
