in order to minimize the economic and legal impacts of litigating the matter at a hearing in front of the Board or otherwise.

TERMS AND CONDITIONS: Defendant's agrees to pay a civil fine of \$500.00 for each violation of K.S.A. § 65-1663 and K.A.R. 68-5-15 for a total of \$1,500.00.

CONSENT OF THE KANSAS STATE BOARD OF PHARMACY: This Consent Agreement is not binding upon the Board until it has been reviewed and agreed to by the Kansas State Board of Pharmacy at its next quarterly meeting, to be held November 30 and December 1, 2011.
