#### CONSENT AGREEMENT

Respondent hereby acknowledges its right to be represented by a lawyer of its own choosing. Knowing these rights, Defendant, by signing this agreement, knowingly and voluntarily suspends these rights at this time, including the right to a hearing by the Board.

FACTS: Defendant neither admits nor denies the facts as presented in the Petition filed in the above-stated matter, and the Board and Defendant agree to enter into this Consent Agreement

in order to minimize the economic and legal impacts of litigating the matter at a hearing in front of the Board or otherwise.

TERMS AND CONDITIONS: Defendant agrees to pay a civil fine in the amount of Three Thousand Five Hundred Eighty and no/100 Dollars (\$3.580.00) which is calculated as follows for its violation of K.S.A. § 65-1637 and K.A.R. 68-1-2a:

\$1,000.00 plus \$20.00 per day for 129 days (Defendant did not have a registered pharmacist in charge from March 23, 2011 until September 28, 2011 for a total of 189 days; less the 30-day notice period; less a 30-day extension which would be granted by the Board, for a total of 129 days).

Agreement is not binding upon the Board until it has been reviewed and agreed to by the Kansas

State Board of Pharmacy at its next quarterly meeting, to be held November 30 and December 1,

2011.
