These costs may include charges for services rendered by the Board's disciplinary counsel, an administrative law judge, and, if applicable, a court reporter.

SUMMARY ORDER

NOW, on this 18th day of April, 2024, comes before the Kansas Board of Pharmacy (the "Board"), through its Executive Secretary, the matter of Courtney Horinek, ("Applicant"), for application for registration as a Kansas pharmacy technician.

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board's Executive Secretary enters this Summary Order in the above-captioned matter. After reviewing the application materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order.

FINDINGS OF FACT

- 1. On February 21, 2024, the Board received Applicant's application for registration as a pharmacy technician in the State of Kansas ("Applicant's Application").
- 2. Applicant answered "No" to the following question on Applicant's Application: "Have you been charged with or convicted of (includes plea of guilty or no contest) a criminal offense or is there any criminal charge now pending against you (other than minor traffic violations) in any state or federal court whether or not a sentence was imposed, suspended, or diverted? This includes misdemeanors." The application directs that if the applicant answers yes, the applicant must attach a Form S-150: Personal History ("Form S-150").

- 3. The Board received information regarding a May 2010 Assault 3rd Degree and a February 2016 operate MV without valid license charged against Applicant.
- 4. On February 26, 2024, the Board emailed and mailed Applicant a letter requesting a completed Form S-150, as well as certified copies of the court pleadings from each case.
- 5. On March 27, 2024, the Board emailed and mailed Applicant a second letter requesting a completed Form S-150, as well as certified copies of the court pleadings from each case.
- 6. On or about April 8, 2024, the Board received the requested documentation, which indicated the following:
 - a. In 2016, Applicant was charged with driving without a license or insurance, to which she pleaded guilty.
 - b. In 2010, Applicant was charged with assault in the third degree, to which she pleaded guilty and was ordered to pay fines and court costs.
 - c. Applicant indicated she did not disclose this on Applicant's Application because she didn't think her past offenses would be relevant and that they would not appear on her record because so much time had elapsed.

CONCLUSIONS OF LAW

- 1. Pursuant to K.S.A. 65-1658, the Board may assess a civil fine not to exceed \$5,000, after notice and an opportunity to be heard, to any registrant for violation of the pharmacy act of the state of Kansas or any other rules or regulations of the state board of pharmacy.
- 2. That pursuant to K.S.A. 65-1663, the Board may take action on an application for issuance or renewal of any registration as a pharmacy technician on any ground which would

authorize the board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.

- 3. Pursuant to K.S.A. 65-1627(a)(1), the Board may take action against the license of any pharmacist upon a finding that the licensee has obtained, renewed or reinstated, or attempted to obtain, renew or reinstate, a license by false or fraudulent means, including misrepresentation of a material fact.
- 4. Since Applicant has two past criminal offense convictions, Applicant's answer of "no" to the disciplinary question(s) on Applicant's Application was a misrepresentation of material fact on an application and a basis to take action against Applicant's Application as a violation of K.S.A. 65-1627(a)(1).

ORDER

Based upon the foregoing findings of fact and conclusions of law, Applicant's Application for issuance of pharmacy technician registration is hereby GRANTED but Applicant is ordered to pay a fine to the Board in the amount of \$300. Applicant has 30 days from the date of this order to pay the fine and the pharmacy technician registration shall be issued upon receipt.

NOTICES

Applicant is hereby notified as follows:

- Applicant may request a hearing pursuant to the Kansas Administrative Procedure
 Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414,
 Topeka, KS 66612-1231 within fifteen (15) days after service of this order.
- 2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.

- 3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.
- 4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is
