**SUMMARY ORDER**

NOW, on this 1st day of August, 2024, comes before the Kansas Board of Pharmacy (the “Board”), through its Executive Secretary, the matter of Della Campos, (“Respondent”).

Pursuant to the authority granted to the Board by the Kansas Pharmacy Act, K.S.A. 65-1625, *et seq.*, and in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board’s Executive Secretary enters this Summary Order in the above-captioned matter. After reviewing the investigation materials and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order.

**FINDINGS OF FACT**

1. The Board has issued Respondent Pharmacy Technician Registration Number 24-118591 authorizing Respondent to perform the functions of a pharmacy technician in the State of Kansas (“Respondent’s Registration”).

2. The Board has previously issued Respondent a Summary Order in case 22-356 for misrepresentation of criminal history on Respondent’s pharmacy technician application. Respondent timely paid a fine.

3. On or about October 7, 2023, the Board received information regarding an October 2023 DUI and transporting open container offense charged against Respondent.

4. On October 6, 2023, the Board sent a letter to Respondent's address of record requesting a completed Personal History Form S-150 ("S-150"), as well as certified copies of the court pleadings from the case.

5. On November 6, 2023, the Board sent a second letter to Respondent's address of record requesting the above documents.

6. On November 6, 2023, the Board received the requested documents from Respondent, which confirmed an arrest for the above offense and indicated Respondent was awaiting the outcome of her case.

7. On July 11, 2024, the Board received court documents from Respondent indicating Respondent had been ordered to complete one year of probation from June 2024 to June 2025.

#### CONCLUSIONS OF LAW

1. That pursuant to K.S.A. 65-1663, the Board may limit, suspend, or revoke a registration or deny an application for issuance or renewal of any registration as a pharmacy technician on any ground which would authorize the board to take action against the license of a pharmacist under K.S.A. 65-1627, and amendments thereto.

2. Pursuant to K.S.A. 65-1627(a)(3), the Board may place in a probationary status the license of any pharmacist who has been found guilty of unprofessional conduct.

3. Pursuant to K.S.A. 65-1626(vvv)(7), unprofessional conduct means conduct likely to deceive, defraud or harm the public.

4. Respondent's recent 2023 DUI offense and placement on one year of probation is a basis to place Respondent's registration in a probationary status pursuant to K.S.A. 65-

1627(a)(3). Additionally, since Respondent has just started her one year of probation, she is therefore unable to show sufficient rehabilitation to warrant the public trust at this time.

### ORDER

Based upon the foregoing findings of fact and conclusions of law, Respondent's Registration is hereby placed on a 2-YEAR probationary status. The terms of Respondent's probation are as follows:

- Respondent must continue compliance with the terms of her probation;
- Respondent must notify the Board of any change in their court status within 10 days of the change;
- Respondent must notify the Board of any arrest or criminal charge within 10 days of the date of the arrest or charge;
- Respondent must notify the Board of any change in employment within 10 days of the change and obtain Board approval for the change;
- Respondent must respond to the Board's regular check-in requests;
- Respondent must inform employers of the probationary status of her pharmacy technician registration;
- Respondent must obtain the signature of her pharmacist-in-charge (PIC) documenting knowledge of her probationary status to the Board; and
- Respondent must comply with all rules and regulations of the Pharmacy Practice Act.

### NOTICES

Respondent is hereby notified as follows:

1. Respondent may request a hearing pursuant to the Kansas Administrative Procedure Act by filing a written request with the Kansas Board of Pharmacy, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1231 within fifteen (15) days after service of this order.

2. If a hearing is not requested as described above, the Order shall become a final order of the Board, effective upon the expiration of the time to request a hearing.


3. Within fifteen (15) days after entry of a final agency order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

4. Within the time limits established in K.S.A. 77-613, either party may seek judicial review of a final agency order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is
