FINAL AGENCY ORDER

On October 17, 2014, the Kansas Board of Pharmacy (the "Board") held a hearing regarding the application of Jessica Allen ("Allen") for a registration to practice as a pharmacy technician in the State of Kansas. Allen appeared in person. Randall J. Forbes of Frieden, Unrein & Forbes, LLP appeared as the Board's Disciplinary Counsel. After considering the evidence admitted at the hearing, the Board enters the following final agency order.

I. FINDING OF FACT

- 1. On June 12, 2014 the Board received an application from Allen seeking registration to practice as a pharmacy technician in the State of Kansas ("Application").
- 2. On July 15, 2014, the Board, through its Investigation Member, issued a Summary Order of Denial denying the Application based upon disciplinary action taken by the Missouri Board of Pharmacy against Allen and the Board's prior order in Case Number 10-65 revoking Allen's Kansas registration ("Summary Order").
 - 3. Following issuance of the Summary Order, Allen timely requested a hearing.
- 4. Allen does not wish to practice as a pharmacy technician in a situation in which drugs would be available to her. Allen consents to the Board granting the Application on the condition that she not work in an area where she has access to drugs.

II. CONCLUSIONS OF LAW AND FACT

1. Pursuant to K.S.A. 65-1663(e)(1) the Board may deny an application for issuance of a registration as a pharmacy technician or limit the applicant's registration on any grounds which would authorize the Board to take disciplinary action, pursuant to K.S.A. 65-1627, and

amendments thereto, against a license to practice pharmacy.

2. Pursuant to 65-1627(a)(12), the Board can take disciplinary action against a

license to practice as a pharmacist based upon the pharmacist having been disciplined by another

state's Board of Pharmacy.

3. Allen's registration should be limited so as to prohibit her from working as a

pharmacy technician in any situation or area in which she would have access to drugs.

III. FINAL ORDER

Based upon the evidence introduced at the hearing held October 17, 2014 and the

foregoing findings and conclusions, Allen's Application is GRANTED with the restriction that

she is prohibited, until further order of the Board, from working as a pharmacy technician in any

situation or area in which she would have access to drugs.

Within fifteen (15) days after service of this Final Agency Order, either party may file a

petition for reconsideration pursuant to K.S.A. 77-529.

Within the time limits established in K.S.A. 77-613, either party may seek judicial review

of this Final Agency Order, pursuant to said statute. The agency officer designated to receive
